ALL THAT PORTION OF SECTIONS 13, 23, 24, 25 AND 26 OF TOWNSHIP 1 NORTH, RANGE 5 WEST AND SECTIONS 18, 19 AND 30 TOWNSHIP 1 NORTH, RANGE 4 WEST, SAN BERNARDINO MERIDIAN, IN THE COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

BEGINNING AT POINT ON THE EXISTING CORPORATE CITY LIMITS OF THE CITY OF SAN BERNARDINO, PER INCORPORATION OF THE CITY OF SAN BERNARDINO, SAID POINT BEING THE CENTERLINE INTERSECTION OF HIGHLAND AVENUE AND CALIFORNIA STREET;

- 1) THENCE ALONG SAID EXISTING CITY BOUNDARY, WESTERLY ALONG THE CENTERLINE OF HIGHLAND AVENUE, TO AN INTERSECTION WITH THE CENTERLINE OF STATE STREET, SAID INTERSECTION BEING ON THE EAST LINE OF ANNEXATION NO. 265, LAFCO NO. 980;
- 2) THENCE FOLLOWING ANNEXATION NO. 265, THROUGH ITS VARIOUS COURSES AS DESCRIBED THEREIN, NORTHERLY, ALONG THE CENTERLINE OF SAID STATE STREET TO A POINT OF INTERSECTION WITH THE EASTERLY PROLONGATION OF THE NORTHERLY LINES OF LOTS 8, 9, 10 AND 11 OF TRACT NO. 2243, AS PER PLAT RECORDED IN BOOK 32 OF MAPS, PAGES 21 AND 22, RECORDS OF SAN BERNARDINO, CALIFORNIA;
- 3) THENCE WESTERLY, ALONG SAID PROLONGATION 850.00 FEET MORE OR LESS TO THE NORTHWEST CORNER OF SAID LOT 11 OF SAID TRACT NO. 2243, SAID POINT ALSO BEING THE NORTHEASTERLY LINE OF LOT 15 OF THE POPE TALBOT AND PIERCE ADDITION AS PER PLAT RECORDED IN BOOK 11 OF MAPS, PAGE 38, RECORDS OF SAN BERNARDINO, CALIFORNIA;
- 4) THENCE NORTHWESTERLY, ALONG SAID NORTHEASTERLY LINE 81.92 FEET TO THE SOUTHWEST CORNER OF LOT 13 OF SAID TRACT NO. 2243;
- 5) THENCE NORTHERLY, ALONG THE WEST LINE OF SAID LOT 13 AND ITS NORTHERLY PROLONGATION A DISTANCE OF 272.34 FEET TO THE CENTERLINE OF ADAMS STREET;

- 6) THENCE WESTERLY, ALONG THE CENTERLINE OF SAID ADAMS STREET A DISTANCE OF 431.89 FEET TO A POINT ON THE CENTERLINE OF MACY STREET, SAID POINT ALSO BEING ON THE EASTERLY LINE OF SAID EXISTING BOUNDARY OF THE CITY OF SAN BERNARDINO, AS ESTABLISHED BY ANNEXATION NO. 102;
- 7) THENCE LEAVING SAID ANNEXATION NO. 265 AND FOLLOWING SAID ANNEXATION NO. 102, THROUGH ITS VARIOUS COURSES AS DESCRIBED THEREIN, NORTHERLY, ALONG THE CENTERLINE OF SAID MACY STREET A DISTANCE OF 120.00 FEET MORE OR LESS TO THE SOUTHEASTERLY PROLONGATION OF THE NORTHEASTERLY LINE OF TRACT NO. 3948, AS PER MAP RECORDED IN BOOK 60 OF MAPS, PAGES 51 THROUGH 53 INCLUSIVE, RECORDS OF SAN BERNARDINO, CALIFORNIA;
- 8) THENCE NORTH 44°23'15" WEST ALONG SAID NORTHEASTERLY LINE TO THE NORTHEAST CORNER OF LOT 43 OF SAID TRACT NO. 3948;
- 9) THENCE NORTH 89°26'38" WEST ALONG THE NORTHERLY LINE OF SAID LOT 43 A DISTANCE OF 149.79 FEET TO THE NORTHWEST CORNER OF SAID TRACT 3948, SAID POINT ALSO BEING THE NORTHWEST CORNER OF SAID ANNEXATION NO. 102;
- 10) THENCE SOUTH 0°34'22" WEST ALONG THE WEST LINE OF LOTS 44 TO 51 OF SAID TRACT NO. 3948 AND THEIR SOUTHERLY PROLONGATION TO THE INTERSECTION WITH THE CENTERLINE OF HIGHLAND AVENUE;
- 11) THENCE LEAVING SAID ANNEXATION NO. 102 AND CONTINUING ALONG THE EXISTING CITY OF SAN BERNARDINO BOUNDARY, WESTERLY ALONG SAID CENTERLINE OF HIGHLAND AVENUE, TO A POINT ON THE EXISTING CITY OF RIALTO INCORPORATED CITY LIMITS, SAID POINT BEING ON THE EAST LINE OF SECTION 36, TOWNSHIP 1 NORTH, RANGE 5 WEST, SAN BERNARDINO MERIDIAN;
- 12) THENCE LEAVING SAID EXISTING CITY OF SAN BERNARDINO BOUNDARY AND CONTINUING ALONG SAID CITY OF RIALTO BOUNDARY, WESTERLY ALONG SAID CENTERLINE OF HIGHLAND AVENUE TO ITS INTERSECTION WITH THE CENTERLINE OF EUCALYPTUS AVENUE, SAID INTERSECTION BEING THE NORTHEAST CORNER OF THE EXISTING BOUNDARY OF THE CITY OF RIALTO AS ESTABLISHED BY ANNEXATION NO. 70;
- 13) THENCE ALONG SAID ANNEXATION NO. 70, WESTERLY ALONG SAID CENTERLINE OF HIGHLAND AVENUE TO THE INTERSECTION WITH THE CENTERLINE OF ACACIA AVENUE;

- 14) THENCE LEAVING SAID ANNEXATION NO. 70 AND CONTINUING ALONG SAID EXISTING BOUNDARY OF THE CITY OF RIALTO, WESTERLY ALONG SAID CENTERLINE OF HIGHLAND AVENUE TO THE INTERSECTION WITH THE WEST LINE OF THE EAST ½ OF LOT 125 OF THE SEMI-TROPIC LAND AND WATER COMPANY SUBDIVISION, AS PER PLAT RECORDED IN BOOK 6 OF MAPS, PAGE 12, RECORDS OF SAN BERNARDINO, CALIFORNIA, SAID POINT ALSO BEING THE SOUTHEAST CORNER OF THE CITY OF RIALTO ANNEXATION NO. 80;

- 33) THENCE DUE EAST A DISTANCE OF 120.00 FEET TO AN ANGLE POINT THEREOF, SAID POINT BEING THE CENTERLINE OF SAID SOUTHERN PACIFIC RAILROAD RIGHT-OF-WAY;




