**DISSOLUTION OF CSA 38 IMPROVEMENT ZONE M AND
FORMATION OF SERVICE ZONE PM-3
(YUCAIPA PARAMEDIC)
OF THE
SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT**

All of those portions in the unincorporated territory of the County of San Bernardino, State of California, lying within the following described boundaries:

Area 1:

The South half of Section 13, Township 1 South, Range 2 West, San Bernardino Meridian.

This area contains 331.6 acres, more or less.

Area 2:

Those portions of Sections 23, 26, 27, and 28, Township 1 South, Range 2 West, San Bernardino Meridian, described as follows:

Beginning at the Southeast corner of Section 28, Township 1 South, Range 2 West, San Bernardino Meridian, said point being also on the existing boundary of the City of Yucaipa per "Incorporation";

1. Thence westerly along said existing city boundary line to the west line of the East half of said Section 28;
2. Thence leaving said existing city boundary and continuing northerly along said west line to the north line of the South half of the Southeast Quarter of said Section 28;
3. Thence easterly along said north line to the west line of Section 27, said township and range;
4. Thence northerly along said the west line to the north line of the South half of said Section 27;
5. Thence easterly along said north line to the west line of the East half of the Northwest Quarter of said Section 27;

6. Thence northerly along said west line to the north line of said Section 27, said point being also on the existing boundary of the City of Redlands per "Annexation No. 29";
7. Thence along said existing city boundary line through its various courses, in a generally easterly and northerly direction to the north line of the South half of said Section 23, said township and range;
8. Thence leaving said existing city boundary and continuing easterly along said north line of the south half of said Section 23, to the west line of the East half of said Section 23;
9. Thence northerly along said west line of the east half to a point on the existing boundary of the City of Redlands per "Annexation No. 4";
10. Thence easterly along said existing city boundary to a point on the existing boundary of the City of Yucaipa per "LAFCO 2629";
11. Thence leaving said existing boundary of the City of Redlands and continuing along said existing boundary of the City of Yucaipa per "LAFCO 2629" and "Incorporation", through its various courses, in a generally southerly, easterly, southerly, westerly, southerly and westerly direction to the **Point of Beginning**.

This area contains 1,458.9 acres, more or less.

Area 3:

That portion of Section 20, All of Section 21 through 23, 25 through 28, and 33 through 36, Township 1 South, Range 1 West, And all of Sections 1 through 3, 11 and 12, and a portion of Sections 4 and 10, Township 2 South, Range 1 West, And all of Sections 29 through 32, Township 1 South, Range 1 East, all of San Bernardino Meridian, more particularly described as follows:

Beginning at the southwest corner of said Section 11, said corner being on the common boundary line between Riverside and San Bernardino Counties and the City of Yucaipa;

1. Thence leaving the existing common boundary line, and continuing along the existing boundary of the City of Yucaipa per "Incorporation", "LAFCO 2823", "LAFCO 2728", and "Incorporation", through its various courses, in a generally northerly, southwesterly, northerly, westerly, northerly, westerly and northerly to the north line of said Section 20, Township 1 South, Range 1 West, San Bernardino Meridian;


2. Thence easterly along the north line of said Section 20 and continuing easterly along Section lines to the Northeast comer of said Section 23, said township and range;
3. Thence southerly along the east line of said Section 23 to the north line of Section 25, said township and range;
4. Thence easterly along said north line to the Northeast comer of said Section 25;
5. Thence southerly along the east line of said Section 25 and the range line between Ranges 1 West and 1 East, to the Northwest comer of Section 30, said Township 1 South, Range 1 East, San Bernardino Meridian;
6. Thence easterly along the north line of Sections 30 and 29, said township and range, to the Northeast comer of said Section 29;
7. Thence southerly along the east line of Sections 29 and 32, said township and range, to the Southeast comer of said Section 32, said point being on the existing common boundary line between Riverside and San Bernardino counties;
8. Thence along said existing common boundary line, through its various courses, in a generally westerly, southerly and westerly direction to the **Point of Beginning**.

This area contains 13,595.7 acres, more or less.

The total area contains 15,386.2 acres (or 24 square miles), more or less.
