

LAFCO 3000 COUNTY FIRE REORGANIZATION

FORMATION OF THE MOUNTAIN SERVICE ZONE OF THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT

All of the unincorporated territory in the County of San Bernardino, State of California, together with those portions of land lying within the following described boundary:

Commencing at the intersection of the common boundary line between Los Angeles and San Bernardino Counties with the north line of Section 6, Township 2 North, Range 7 West, San Bernardino Meridian;

Thence leaving said common boundary line easterly along the north line of Township 2 North, Range 7 West, and continuing easterly along the north line of Township 2 North, Ranges 6 and 5 West, to the northeast corner of Section 4, Township 2 North, Range 5 West, San Bernardino Meridian and the **True Point of Beginning**;

1. Thence continuing easterly along said township line, to the Northeast corner of Section 1, Township 2 North, Range 4 West, San Bernardino Meridian;
2. Thence southerly along the east line of Section 1 to the northwest corner of Section 6, Township 2 North, Range 3 West, San Bernardino Meridian;
3. Thence easterly along the north lines of said Section 6 and Section 5, said township and range, to the southwest corner of Section 32, Township 3 North, Range 3 West, San Bernardino Meridian;
4. Thence northerly along the west line of said Section 32 and continuing northerly along the west lines of Sections 29 and 20, said township and range, to the northwest corner of said Section 20;
5. Thence easterly along the north line of said Section 20 and continuing along the north lines of Section lines to the northeast corner of Section 21, Township 3 North, Range 2 West, San Bernardino Meridian;
6. Thence southerly along the east line of said Section 21 to the northwest corner of Section 27, said township and range;
7. Thence easterly along the north line of said Section 27 and continuing along the north lines of Section lines to the southwest corner of Section 21, Township 3 North, Range 1 West, San Bernardino Meridian;

8. Thence northerly along the west line of said Section 21 to the northwest corner of said Section 21;
9. Thence easterly along the north line of said Section 21, and continuing along the north lines of Section lines to the northeast corner of Section 24, Township 3 North, Range 1 East, San Bernardino Meridian, said corner being a point on the range line between Ranges 1 and 2 East;
10. Thence southerly along said range line to the northwest corner of Section 30, Township 3 North, Range 2 East, San Bernardino Meridian;
11. Thence easterly along the north line of said Section 30, and continuing easterly along the north lines of Section lines to the northeast corner of Section 29, Township 3 North, Range 3 East, San Bernardino Meridian;
12. Thence southerly along the east line of said Section 29 and continuing along the east lines of Section lines to the southeast corner of Section 29, Township 1 North, Range 3 East, San Bernardino Meridian;
13. Thence westerly along the south lines of said Section 29 and Section 30, said township and range, to the Southwest corner of Section 30, said corner being on the range line between Ranges 2 and 3 East;
14. Thence southerly along said range line to the southeast corner of Section 36, Township 1 North, Range 2 East, San Bernardino Meridian, said corner being on the township line between Townships 1 North and 1 South;
15. Thence westerly along said township line to the northeast corner of Section 1, Township 1 South, Range 2 East, said corner being on the range line between Ranges 2 and 3 East, San Bernardino Base Meridian;
16. Thence southerly along said range line to its intersection with the common boundary line between Riverside and San Bernardino Counties;
17. Thence westerly along said common boundary line to the southeast corner of Section 32, Township 1 South, Range 1 East, San Bernardino Meridian;
18. Thence leaving said common boundary line, northerly along the east lines of said Section 32 and Section 29, said township and range, to the northeast corner of said Section 29;
19. Thence westerly along the north lines of said Section 29 and Section 30, said township and range, to the northwest corner of said Section 30, said corner being on the range line between Ranges 1 West and 1 East;

20. Thence northerly along said range line to the northeast corner of Section 25, Township 1 South, Range 1 West, San Bernardino Meridian;
21. Thence westerly along the north line of said Section 25 to the northwest corner of said Section 25;
22. Thence northerly along the east line of Section 23, said township and range, to the northeast corner of said Section 23;
23. Thence westerly along the north lines of said Section 23 and Section 22, said township and range, to the northwest corner of said Section 22;
24. Thence northerly along the east line of Section 16, said township and range, to the northeast corner of said Section 16;
25. Thence westerly along the north line of said Section 16 and continuing westerly along the north lines of Sections 17 and 18, said township and range, to the northwest corner of said Section 18, said corner being on the range line between Ranges 1 and 2 West;
26. Thence northerly along said range line to the northeast corner of Section 12, Township 1 South, Range 2 West, San Bernardino Meridian;
27. Thence westerly along the north lines of Sections 12, 11, and 10, said township and range, to the northwest corner of said Section 10;
28. Thence northerly along the east line of Section 4, said township and range, to the northeast corner of said Section 4, said point being on the township line between Townships 1 North and 1 South, San Bernardino Meridian;
29. Thence westerly along said township line between Townships 1 North and 1 South, to the southeast corner of Section 31, Township 1 North, Range 2 West;
30. Thence northerly along the east lines of said Section 31 and Section 30, said township and range, to the northeast corner of said Section 30;
31. Thence westerly along the north line of said Section 30 and continuing westerly along the north line of Section 25, Township 1 North, Range 3 West, San Bernardino Meridian, to the northwest corner of said Section 25;
32. Thence northerly along the east line of Section 23, said township and range, to the northeast corner of said Section 23;
33. Thence westerly along the north line of said Section 23 and continuing westerly along the north lines of Sections 22 and 21, said township and range, to the northwest corner of said Section 21;

34. Thence northerly along the east line of Section 17, said township and range, to the northeast corner of said Section 17;
35. Thence westerly along the north line of said Section 17 to the northwest corner of said Section 17;
36. Thence northerly along the east line of Section 7, said township and range, to the northeast corner of said Section 7;
37. Thence westerly along the north line of said Section 7 to the northwest corner of said Section 7; said point being on the range line between Ranges 3 and 4 West;
38. Thence northerly along said range line to the northeast corner of Section 1, Township 1 North, Range 4 West, San Bernardino Meridian, said corner being on the township line between Townships 1 and 2 North, San Bernardino Meridian;
39. Thence westerly along said township line to the intersection thereof with the westerly Right-of-Way line of State Highway 18;
40. Thence northwesterly and westerly along said westerly Right-of-Way line following all its various courses to the intersection thereof with the west line of the southwest quarter of the southeast quarter of Section 34, Township 2 North, Range 4 West, San Bernardino Meridian;
41. Thence southerly along the west line of said southwest quarter of the southeast quarter of Section 34, to the south line of said Section 34;
42. Thence westerly along said south line and continuing along the south line of Section 33, said township and range, to the southwest corner of said Section 33;
43. Thence northerly along the west line of said Section 33, to the northwest corner of said Section 33;
44. Thence westerly along the north line of Section 32, said township and range, to the northwest corner of said Section 32;
45. Thence northerly along the east line of Section 30, said township and range, to the northeast corner of said Section 30;
46. Thence westerly along the north line of said Section 30 to the northwest corner of said Section 30, said point being on the range line between Ranges 4 and 5 West;
47. Thence northerly along said range line to the northeast corner of Section 24, Township 2 North, Range 5 West, San Bernardino Meridian;

48. Thence westerly along the north line of said Section 24 and continuing westerly along the north lines of Sections 23 and 22, said township and range, to the northwest corner of said Section 22;
49. Thence northerly along the east line of Section 16, said township and range, and continuing northerly along the east lines of Sections 9 and 4, said township and range, to the **True Point of Beginning**.


EXCEPTING THEREFROM those portions of land lying within the boundaries of the following cities and districts:
