Vegas man arrested in Hesperia on suspicion of possessing dangerous fireworks for sale and child endangerment

HESPERIA — A 27-year-old man was arrested on suspicion of possessing dangerous fireworks for sale and child endangerment in Hesperia Wednesday afternoon, authorities said.

At 12:36 p.m. detectives from the Victor Valley Sheriff's Station arrested Markneil-Aldrin Lilbutan, 27, of Las Vegas, for possession of dangerous fireworks for sale, child endangerment and illegal possession of a loaded firearm, authorities said.

Acting on a tip from a concerned citizen, detectives staged a meeting with Lilbutan, who believed the detectives were residents wanting to purchase illegal fireworks he had for sale, according to authorities.

Lilbutan showed up with his 3-month-old son at the 13000 block of Main Street in Hesperia with over 1,500 pounds of illegal fireworks and a loaded firearm in his truck.

Assisted by deputies from the Hesperia Sheriff's Station and **San Bernardino County Fire Department** officials, detectives were able to detain Lilbutan at the scene.

Lilbutan was arrested and booked at the High Desert Detention Center and the infant was released to his mother, authorities said.

Police Seize 1,500 Pounds of Illegal Fireworks in Hesperia

HESPERIA:(VVNG.com)- A 27-year-old Las Vegas man was arrested for possession of dangerous fireworks for sale, child endangerment, and illegal possession of a loaded firearm.

Authorities said they received a tip from a concerned citizen on Wednesday, May 25th regarding the sale of illegal fireworks.

Detectives contacted the suspect, Markneil-Aldrin Lilbutan and pretended to be residents who were interested in purchasing illegal fireworks. A meeting was staged with the suspect at 13401 Main Street in Hesperia. Lilbutan showed up to the meeting location with his three-month-old son, 1,500 pounds of illegal fireworks, and a loaded firearm in his truck.

Assisted by deputies from the Hesperia Police Department and **San Bernardino County Fire** Personnel, detectives were able to detain the suspect at the scene. Lilbutan was arrested and booked at the High Desert Detention Center. The infant was released to his mother.

California Helmet Cam: Pin Job in Victorville

San Bernardino County firefighters respond to a collision between a garbage truck and a pickup

San Bernardino County Fire Department - Victorville, Just before 12:35 p.m yesterday #SBCoFD received reports of a traffic collision in the area Green Tree Blvd and First Avenue. A traffic collision with injuries was dispatched which included one Paramedic Engine and an AMR ambulance.

While enroute additional reports stated victims were possibly trapped. The assignment was modified at that point to include a Paramedic Truck company and a Chief Officer. The first arriving engine reported one immediate driver trapped in a collision involving a mid sized vehicle and a garbage truck.

Crews initiated extrication as well as patient care to the victim trapped inside. The vehicle sustained major front end and drivers side damage. Firefighters used multiple hydraulic powered extrication tools to remove

the vehicle from around the patient. It took Firefighters approximately 20 minutes extricate the victim. An air ambulance was requested to transport the patient to a trauma center down the hill. Once the victim was transported to the landing zone at Victor Valley Hospital he was evaluated and stabilized.

County Fire responded with 1 paramedic engine company, 1 paramedic truck, 1 chief officer for a total of 7 personnel. The cause of the accident is currently under investigation by the San Bernardino County Sheriff's Department.
