

**BAIL BOND INFORMATION**

We accept cash or bail bonds. Bail bonds need to be issued by a state approved bail bond agency. The personnel of San Bernardino County Sheriff's Department are prohibited from endorsing or recommending any specific bail bond agency.

Cash bails are processed at the Lobby of this facility. A posted cash bail must be the full amount of bail for each charge. A cashier's check, in lieu of cash, can be accepted. Checks must be payable to the agency designated by the facility.

**GENERAL INFORMATION**

General Information may be obtained by calling (760) 530-9300, 24 hours a day, 7 days a week.

**VISITING INFORMATION**

All **visits must be scheduled by phone**, 24 hours in advance, from 8:00AM to 7:30PM, Tuesday through Saturday. Inmates are allowed one (1) visit per day with a maximum of two (2) guests. **Visiting days** are Wednesday through Sunday from 8:30AM to 8:00PM. Visitors must arrive 20 minutes prior to their scheduled time. Late arrivals will not be admitted.

Inmates under special classifications may have a different set of visiting guidelines.

Call information for inquiries. The visiting appointment line is (909) 887-0364. Inmates under disciplinary restrictions are not allowed visits.

**ACCEPTABLE IDENTIFICATION**

All visitors 18 years and older must have a valid government issued identification card such as Department of Motor Vehicles ID or Driver's License, County or state Employee ID, Military ID and/or US Passport.

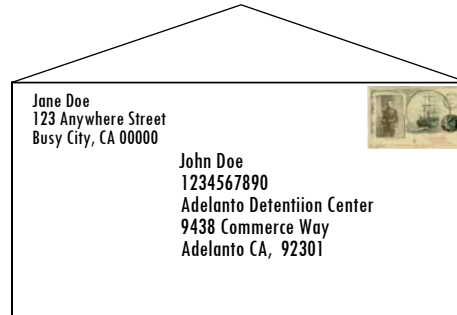

## INMATE MAIL

All inmate mail must have the following information printed on the outside of a plain envelope:

Name of sender; return address: Inmate's name; booking number (if known): Facility Address.



### **DO NOT**

1. Do not send blank paper, envelopes or stamps.
2. Do not put perfume, powder or cologne on letters.
3. Do not kiss inmate correspondence.
4. Do not send letters that are stained or extremely dirty. Food items are not allowed.
5. Do not send more than ten, 5x7 or smaller, photos and no frames or accessories..
6. Do not send anything depicting violence, sex or gang affiliation.
7. Do not send nude or partially nude photos or drawings.
8. Do not use whiteout, crayon or markers on inmate mail.
9. Do not send metal or plastic in inmate mail.
10. Do not send cards or letters with glue, tape, glitter, stickers or labels.
11. Note: All books and magazines must come from the *publisher* and must be *paperback*.

## INMATE MONEY

We accept Cashier's Checks and Money Orders. Cashier Checks or Money Orders should be made payable to the Adelanto Detention Center with the name and booking number of the inmate included on the check/order. **No personal checks are accepted.**

Cash deposits are processed at the Front Lobby of this facility. Deposit slips must be completed to be enclosed with the exact amount of money. The Front Lobby is open to the public 24 hours a day, seven (7) days a week.

The Department maintains individual accounts for each inmate in which deposits and withdrawals are posted. Upon release from custody, the inmate will be paid his/her account balance by check, cash or a combination of both. Checks issued by the facility can be cashed at any branch of Citizens Business Bank or any check-cashing place.
