

Hantavirus

The vector-borne disease Hantavirus has been making headlines in the news over the past few months. The outbreak in Yosemite National Park was one of the worst Hantavirus outbreaks in recent memory in the United States. According to the CDC, there have been 10 confirmed cases of Hantavirus as of November 1, 2013 in people that had recently visited Yosemite.

Did you know that <u>rodent control</u> in and around camps and the home is the best way to prevent Hantavirus? Deer mice, cotton rats, rice rats, and white-footed mice are known to carry Hantavirus, so make sure to keep these critters away from your camp or home!
