The short title of the action is: **LAFCO 3233A – Reorganization to Include Dissolution of County Service Area 64 and Formation of the Spring Valley Lake Community Services District together with the Formation of Zone A for Solid Waste and Streetsweeping.**

The change of organization was disapproved by majority of the voters that voted at the Presidential General Elections on November 3, 2020. Resolution No. 3322 terminating the reorganization, pursuant to Government Code Section 57179, was adopted by the Executive Officer of the Local Agency Formation Commission on December 22, 2020. RESOLUTION NO. 3322

A RESOLUTION OF THE EXECUTIVE OFFICER OF THE LOCAL AGENCY FORMATION COMMISSION FOR SAN BERNARDINO COUNTY MAKING DETERMINATIONS ON LAFCO 3233A, TERMINATING THE REORGANIZATION TO INCLUDE DISSOLUTION OF COUNTY SERVICE AREA 64 AND FORMATION OF THE SPRING VALLEY LAKE COMMUNITY SERVICES DISTRICT TOGETHER WITH THE FORMATION OF ZONE A FOR SOLID WASTE AND STREETSWEeping PURSUANT TO GOVERNMENT CODE SECTION 57179

WHEREAS, this action is being taken pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (Government Code Sections 56000 et seq.); and,

WHEREAS, the Executive Officer, on behalf of the Local Agency Formation Commission for San Bernardino County (the "Commission"), serving as the conducting authority for LAFCO 3233A to include dissolution of County Service Area 64 and formation of the Spring Valley Lake Community Services District together with the formation of Zone A for Solid Waste and Streetsweeping (the "Reorganization" or "LAFCO 3233A"), adopted Resolution No. 3309 on May 18, 2020 making determinations and ordering the Reorganization subject to confirmation of the voters and requested the County Board of Supervisors set the matter on the November 3, 2020 Presidential General Election; and,

WHEREAS, a ballot measure—Measure V—was placed on the November 3, 2020 Presidential General Election for the purpose of determining whether or not the Reorganization should be approved subject to the terms and conditions as described in the order; and,

WHEREAS, the results of the November 3, 2020 Presidential General Election has been certified by the San Bernardino County Registrar of Voters on December 1, 2020, with Measure V receiving the following breakdown of votes:

1,428 votes were cast for the Reorganization
3,332 votes were cast against the Reorganization

NOW, THEREFORE, BE IT RESOLVED, that the Executive Officer, on behalf of the Commission, hereby determines and orders termination of LAFCO 3233A due to majority of the voters who voted disapproved said Measure V.
