

The application was initiated by landowner petition for a reorganization to include annexation of 19+/acres to the City of Rialto and West Valley Water District and detachment from the San Bernardino County Fire Protection District, its Valley Service Zone, and County Service Area 70. The reorganization area encompasses a single parcel, APN 0239-121-20, generally located northeast of the Riverside Avenue between Locust and Linden Avenues.

The exemption request relates to an agreement to provide water service to four parcels, Assessor Parcel Numbers 0304-082-12, 0304-091-12, 0304-091-21, and 0304-091-22, which encompass the area to be developed as the Moon Camp Project (Tentative Tract 16136), located along the North Shore of Big Bear Lake, in the unincorporated community of Fawnskin.

 Consideration of: (1) Review of Negative Declaration Prepared by County of San Bernardino for Planned Development, General Plan Amendment to Change the Land Use from Single Residential 20,000 Sq.Ft. Minimum to Special Development-Planned Residential Development, and Tentative Tract 18902 to Create 36 Lots on 6.86 Acres, as CEQA Responsible Agency for LAFCO SC#400; and (2) LAFCO SC#400 – City of Chino Irrevocable Agreement to Annex for Water and Sewer Services (Tentative Tract 18902 – APNs 1016-521-03, -04, and 05) The agreement relates to three parcels, Assessor Parcel Numbers 1016-521-03, 1016-521-04, and 1016-521-05, located on the west side of Pipeline Avenue generally north of Riverside Drive, which is within the City of Chino's western sphere of influence.
