

The application proposes the formation of the Wrightwood Community Services District with the powers to provide streetlighting, solid waste and park and recreation services and dissolution of County Service Area 56, which currently provides streetlighting and park and recreation services to a portion of the area that is within San Bernardino County. The Commission will also consider the potential to expand the functions and services to be provided by the Wrightwood Community Services District to include the services of planning, engineering under a wastewater function. The proposed community services district encompasses approximately 17 square miles (10,866+/- acres) located in the San Gabriel Mountains generally along the Angeles Crest Highway (State Route 2) east and west of the Los Angeles and San Bernardino County line. The area is located east of the unincorporated community of Big Pines and west of State Route 138 in the Angeles National Forest, which is the area generally identified as the community of Wrightwood.
