The City of Chino initiated the proposal for reorganization to include annexation to the City of Chino and detachment of County Service Areas for the area identified as the Pipeline Island, being a substantially surrounded island of unincorporated territory. The area encompasses approximately 40 acres, generally bordered by Hacienda Lane and parcel lines (existing City of Chino boundary) on the north, parcel lines and Norton Avenue (existing City of Chino boundary) on the east, Chino Avenue and parcels lines (existing City of Chino boundary) on the south, and Pipeline Avenue on the west. The reorganization area is located in the City of Chino's western sphere of influence.

The staff recommendation may be accepted or rejected by the Commission after its own analysis and consideration of public testimony.

IF YOU CHALLENGE ANY DECISION REGARDING ANY OF THE ABOVE PROPOSALS IN COURT, YOU MAY BE LIMITED TO RAISING ONLY THOSE ISSUES YOU OR SOMEONE ELSE RAISED DURING THE PUBLIC TESTIMONY PERIOD REGARDING THAT PROPOSAL OR IN WRITTEN CORRESPONDENCE DELIVERED TO THE LOCAL AGENCY FORMATION COMMISSION AT, OR PRIOR TO, THE PUBLIC HEARING.

The Political Reform Act requires the disclosure of expenditures for political purposes related to a change of organization or reorganization proposal which has been submitted to the Commission, and contributions in support of or in opposition to such measures, shall be disclosed and reported to the same extent and subject to the same requirements as provided for local initiative measures presented to the electorate (Government Code Section 56700.1).
