**Item B**

The community of Spring Valley Lake, as well as its Homeowners Association and Board of Directors, have always understood the importance of protecting our most valuable asset, our beautiful lake.

Presently, runoff from the streets of our community flows directly into drainage culverts that fail to efficiently keep trash and other pollutants from entering our lake water.

As you are aware, Spring Valley Lake is a flow-through body of water that feeds back into the Mojave Narrows and Mojave River, eventually serving as part of the drinking water source for the Barstow area which in itself makes it imperative that our water quality be maintained and protected.

Our Spring Valley Lake Association is diligent in reminding our residents to be mindful of gardening debris, litter in our gutters and the use of chemicals that may run off and end up in our lake. As careful as we may be, the desert winds are a constant challenge for us causing leaves and litter to wind up in our drainage system. Eventually, despite our best efforts, this all will unfortunately make its way into our lake.

Therefore today we are reaching out to you, our San Bernardino County Board of Supervisors, Public Works and Environmental Health to request assistance in the task of mitigating this pollution. This may require the upgrading of our present drainage system to more efficient storm drains and making sure they are part of a regular maintenance schedule. An upgrade to our drainage system would be supportive of your San Bernardino County Master Storm Water System Maintenance Program (MSWSMP) as our lake connects to your mapped program area.

We are seeking to begin this much needed conversation and will look forward to your reply.
