It is our pleasure to inform you that on Thursday, August 11, 2016, the County of San Bernardino Interagency Council on Homelessness (ICH) Grant Review Committee (GRC) voted to recommend the Salvation Army Permanent Supportive Housing-Bonus Project in the amount of \$200,000 to ICH for inclusion in the Fiscal Year (FY) 2016 Housing and Urban Development (HUD) Continuum of Care (CoC) Program submission to HUD.
