Description of Project and LEA's Preliminary Determination

The changes include:

• Non-water release corrective action cost estimate, site life closure cost estimate, postclosure maintenance cost estimate.

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on February 20, 2015.
