Description of Project and LEA's Approval

SCOR Industries Medium Volume CDI Facility will be receiving up to 174 tons per day of construction demolition and inert (CDI) material generated by new residential construction and demolition sites. All material will be removed generally within 48 hours and no hazardous material will be accepted. This site will be operating Monday to Saturday from 6 am to 6 pm and occasionally on Sundays from 7 am to 6:30 pm. On August 12, 2014 the LEA accepted the Registration Permit application and Facility Plan submitted by the operator of SCOR Industries Medium Volume CDI Facility as complete and correct for filing. The LEA finds the CDI Debris Processing Facility consistent with the requirements of Title 14 of the California Code of Regulations and has issued a permit to operate a Medium Volume Construction and Demolition/Inert Debris Processing Facility.
