**Inspector Comments:** WASTE EGGS BUCKETS STILL ARE OPEN AND ATTRACTING FLIES. BUCKETS NEED A LID OR CLEAN OUT COMPLETELY WITH NO EGG YOLK ON INSIDE OR OUTSIDE OF THE BUCKET.

**Description:** Waste eggs shall be disposed of by one of the following methods:

- (A) Placed daily in the dead bird disposal;
- (B) Placed in fly-tight containers or structures and removed from the premises at least weekly.

#### 40K141 Operation - Frequent Manure Removal

**Inspector Comments:** WET MANURE IN THE AISLES HAVE NOT BEEN REMOVED. WET MANURE MUST BE REMOVED DOWN ALL AISLES.

**Description:** If the commercial poultry ranch owner or operator employs the frequent manure removal operation method of manure management, the following procedures shall be complied with:

- (A) Manure shall be removed frequently enough from under poultry cages to prevent fly larval migration and adult emergence.
- (B) Each time manure is removed from under the poultry cages, larvae and pupae shall also be removed in the fringe areas.
- (C) Aisles and borders of the poultry houses shall be cleaned of feathers and other debris frequently to eliminate pupation areas for fly larvae.

#### 40K142 Operations - Chemical

**Inspector Comments:** RANCH IS NOT ADULTICIDING 2 TIMES A DAY. RANCH MUST ADULTICIDE 2 TIME A DAY INCLUDING THE WEEKENDS. UNTIL SB COUNTY VECTOR CONTROL TELLS THEM OTHERWISE.

**Description:** Whenever necessary, the fly population on the ranch shall be chemically controlled to prevent nuisances. Larviciding shall be kept at a minimum. Appropriate adulticides, including both sprays and baits, may be used to control adult fly populations.

#### Overall Inspection Comments

WASTE EGGS BUCKETS STILL ATTRACTING FLIES. THEY DID TRY CLEANING THEM OUT BUT DID NOT CLEAN ALL YOLK OFF THE BUCKETS. THEY MUST EITHER CLEAN THE BUCKETS COMPLETELY OR PUT TIGHT LIDS ON THE BUCKETS. RANCH DID NOT ADULTICIDE ON SUNDAY. RANCH MUST ADULTICIDE 2 X A DAY EVERYDAY OF THE WEEK INCLUDING THE WEEKENDS UNTIL SB COUNTY VECTOR CONTROL TELLS THEM OTHERWISE. WET MANURE DOWN AISLE CREATING A FLY BREEDING HAZARD. MANURE MUST BE REMOVED DAILY. RANCH IS MAINTAINING THE WET SPOTS WITH LYME. VERY FEW WETS SPOTS. DID HAVE ONE LARGE WET SPOT IN THE AISLE IN THE 2 HOUSE FROM THE STREET ON THE SOUTH SIDE OF THE PROPERTY. INSTRUCTED THE LED RANCH HAND TO TAKE CARE OF THE SPOT TODAY. BREEDING IS MODERATE. ADULT FLIES MODERATE. NEPROREX WAS APPLIED LAST WEEK. NOV ISSUED AND CHARGED FOR INSPECTION SINCE OWNER DID NOT ADDRESS THE WASTE EGG BUCKETS AND THE MANURE IN THE AISLE FROM LAST WEEKS NOV.
