#### 40K120 Operation - Drying and Coning

**Inspector Comments:** THE PILE OF MANURE TO THE NORTH OF THE HOUSES BETWEEN THE FENCE AND HOUSES HAS BREEDING AROUND THE EDGES. MANURE MUST BE TURNED DAILY AND TREATED FOR BREEDING.

**Description:** If the commercial poultry ranch owner or operator employs the drying and coning operation method of manure management, the following shall be complied with:

(A) The process shall begin on dry ground or on a pad of dry manure in order to harbor predators and parasites and to provide an absorbent surface for fresh droppings. A deeper pad of dry manure may be necessary if the area beneath the poultry cages is sunk below the levels of the aisles. If necessary, to facilitate drying, broken up fresh droppings shall be stirred or otherwise mixed with the dry pad until a satisfactorily dry condition is attained.

(B) Any system used for watering the poultry shall be maintained so as to prevent water from reaching the manure. System leaks shall be promptly repaired so as not to disrupt the effectiveness of the drying method. When necessary, the watering system shall be changed or upgraded to eliminate future leaks.

(C) All wet spots in the manure created by water leaks or diarrheic poultry shall be thoroughly removed and replaced with an adequate base of dry material as necessary.

(D) Whenever it becomes necessary to remove the manure from under the cages, a six to eight inch pad of dry manure shall be left to facilitate the drying of the new cones and maintain a habitat for predators and parasites by one of the following methods:

- (I) Removing every other row, then pushing half of the manure from the remaining row into the cleaned out row.
- (II) Cleaning so as to leave at least six to eight inches of manure in each row.
- (III) Cleaning out all manure and replacing it with at least a six to eight inch pad of dry manure from some other source.

#### 40K141 Operation - Frequent Manure Removal

**Inspector Comments:** WET MANURE IS NOT BEING REMOVED FROM ALL THE HOUSES ON A DAILY BASES. WET MANURE MUST BE REMOVED AND DRY MANURE PUT BACK IN ITS PLACE. RANCH MUST CONTINUE SPOT TREATING THE WETS SPOTS.

**Description:** If the commercial poultry ranch owner or operator employs the frequent manure removal operation method of manure management, the following procedures shall be complied with:

- (A) Manure shall be removed frequently enough from under poultry cages to prevent fly larval migration and adult emergence.
- (B) Each time manure is removed from under the poultry cages, larvae and pupae shall also be removed in the fringe areas.
- (C) Aisles and borders of the poultry houses shall be cleaned of feathers and other debris frequently to eliminate pupation areas for fly larvae.

#### 40K146 Operations - Fly Breeding Hazard

**Inspector Comments:** BROKEN AND LEAKING CUPS CAUSING FLY BREEDING. CUPS AT THE END OF EACH ROW WHEN THE CHICKENS MOVED IT CAUSES THE CUPS TO BOUNCE. WHICH CAUSES THE WATER TO POOL UNDER THE CAGES. IT IS CAUSING FLY BREEDING.

**Description:** The accumulation, existence or maintenance of any substance, matter, material, or condition resulting or likely to result in the breeding of flies in an amount or manner such as to endanger public health or safety, or to create unreasonable interference with the comfortable enjoyment and use of life and property by others.

RANCH IS NOT REMOVING THE WET SPOTS FROM ALL HOUSES DAILY. THE WET SPOTS THE RANCH HAS REMOVED IS STILL WET TO BOTH SIDES OF THE SPOT WITH HEAVY BREEDING. THE APRONS HAVE HEAVY BREEDING. ONE APRON I FOUND A PILE OF MANURE THAT HAD MORE THAN 100 PUPA CASINGS. I REMOVED THE MANURE AND THREW IT INTO THE SUN. RANCH MANAGER STATED THEY ARE ONLY CONCENTRATING ON HOUSES 6,7,8. RANCH IS SPOT TREATING SOME OF THE WET SPOTS. I CAN SEE IT IS WORKING ON THE SPOTS THEY HAVE TREATED. RANCH IS MISSING ALOT OF WET SPOTS WITH HEAVY BREEDING. RANCH NEEDS TO STOP THE CUPS FROM BOUNCING WHICH IS CAUSING WET MANURE. FOUND A WASTE EGG BUCKET THAT WAS LEFT OPEN AND WAS COVERED IN FLIES RANCH MUST COVER ALL WASTE EGG BUCKETS WITH A LID. HEAVY LARVA BREEDING AND HEAVY ADULT POPULATION ON THE RANCH. SPOKE TO THE OWNER AND HE STATES HE IS DOING EVERYTHING HE CAN AND WANTS TO SPEAK WITH MY SUPERVISOR (JENNIFER ASAP). SPOKE WITH JENNIFER WE HAVE SCHEDULED A HEARING WED MORNING WITH YUCIAPA CITY HALL. RANCH OWNER STATED HE WILL NOT DO FREQUENT CLEAN OUTS BECAUSE IT WILL UPSET THE RESIDENCE. HE WILL ONLY DO IT IF THEY AGREE TO IT. OWNER ASKED ABOUT ONLY ADULTICIDING AND NOT REMOVING THE WET MANURE. TOLD HIM I NEED TO CHECK COUNTY CODE AND WITH JENNIFER. DRYING PAD BETWEEN OWNERS HOUSE AND CHICKENS HOUSES LOOKS GOOD ITS DRY WITH NO BREEDING FOUND. THE PILE OF MANURE TO THE NORTH OF THE CHICKEN HOUSES THE EDGES ARE BREEDING. RANCH MANAGER STATED HE IS GOING TO THIN SPREAD THAT MANURE. DEAD PITS ONLY ONE PIT THEY HAVE BEEN COVERING WITH DIRT THE OTHER PIT IT THE SAME SIZE AND IT ATTRACTING FLIES. NOV ISSUED. NO CHANGE.
