RANCH IS RAVAPING 2 TIMES A DAY. RANCH WAS IN THE PROCESS OF SPRAYING ALL THE MANURE WITH TRIAZACIDE. THEY HAD HOUSES 1-4 DONE CAN SMELL THE PESTICIDE AND SEE THAT IT WAS WORKING ON THE BREEDING. THEY WERE STARTING HOUSE 5 WHILE I WAS ON THE RANCH. RANCH HAS STARTED TO PUT DRY MANURE BACK INTO THE HOUSES. DRYING PADS ARE DRY AND HAVE NO BREEDING. RANCH IS GETTING RID OF ONE HOUSE OF BIRDS AND WHEN HE DOES THAT, THE BIRDS IN THE CAGES THAT ARE OVER THE APRONS WILL BE MOVED INTO THAT HOUSE TO REDUCE THE BREEDING OVER THE APRONS AND RESOLVE THE ISSUE WITH THE CUPS SPILLING. ALSO HE STATED THE CUPS WILL BE TURNED OFF FOR THE CAGES OVER THE APRON. DEAD PITS HAS BEEN COVERED. OWNER IS GOING TO A PIG FARM TODAY TO TALK TO THEM ABOUT TAKING BROKEN EGGS TO THEM AND NOT PLACING THE BROKEN EGGS IN THE PIT. RANCH IS REMOVING ALL THE DEBRIS AROUND THE EGG PACKING HOUSE THAT IS ATTRACTING THE FLIES. LARVAL BREEDING IS HEAVY. ADULT POPULATION IS MODERATE. RANCH NEEDS TO SUBMIT NEW MANURE MANAGEMENT PLAN PER MY SUPERVISOR JENNIFER. PLAN IS NOT CURRENT TO WHAT HE IS DOING. RANCH IS STILL WORKING ON MAKING THE NEW ADULT BAIT STATIONS. RANCH NEEDS TO CONTINUE SPRAYING 2 TIMES A DAY. RANCH NEEDS TO CONTINUE WITH SPOT TREATING WET SPOTS. RANCH NEEDS TO CONTINUE REMOVING ALL WET SPOTS AND REPLACING THEM WITH DRY MANURE. RANCH NEEDS TO CONTINUE TO WORK ON THE ADULT BAIT STATIONS. RANCH NEEDS TO CONTINUE TURNING THE DRYING PAD AND SPRAYING THE MANURE WHERE THERE IS BREEDING. RANCH NEEDS TO CONTINUE WORKING ON THE LEAKING CUPS AND BOUNCING CUPS.
