Pesticide log showed Poultry Litter Treatment was last used on 10/10/14, Neporex on 10/6/14 and Evergreen on 10/10/14.

No water system leaks were observed.

Adult fly bait needs to be applied.

Wet manure that is breeding must be removed.

The ranch is in compliance at this time.
