Inspector Comments: Adult fly population is very heavy and must be reduced.

Reference - SBCC - 33.0919(b)

Description: The standards herein shall be interpreted to promote good fly control practices in accordance with recognized biological control practices to reduce the possibility of fly breeding. However, they do not preclude the use of pesticides when necessary or other good fly control practices as approved by DEHS. Additionally, DEHS may require any reasonable action necessary to insure fly control and to prevent a public nuisance.

40K084 Maintenance - Water Systems

Comply by: 3/12/2015
Not In Compliance

Inspector Comments: Water system leaks need to be fixed. Wet manure needs to be removed or treated with

lime. Manure piles are breeding flies because they got wet from the rain.

Reference - SBCC - 33.0920 (a)(2)

Description: All watering and cooling systems shall be so installed to prevent backflow and so maintained that they do not overflow, splash, or leak upon manure and feeds.

40K145 Operations - Fly Bait Stations

Comply by: 3/12/2015
Not In Compliance

Inspector Comments: Adult fly bait stations are not maintained properly (cobwebs are clogging the entrances

) and not attracting flies.

Reference - SBCC - 33.0919 (a)

Description: Fly bait stations, when required by DEHS and approved by DEHS, shall be maintained in an operable condition on each cage operation type ranch or other fly breeding place. The number of fly bait stations shall be determined by DEHS.

Overall Inspection Comments

Inspection found:

Adult fly population was very heavy at the time of inspection.

Pesticide log showed Evergreen last used on 2/25/15 and Neporex on 2/14/15. Pestcide use should be inceased until fly population under control.

Water system leaks were observed and wet manure is breeding flies.

Adult fly bait stations are still not in service and are not properly maintained.

This ranch is in violation at this time.
