21A011 Employee - Dress/Attire

Inspector Comments: OBSERVATION: Employee-Dress/Attire not acceptable. Ms Ding was observed with a white tight dress which was observed to be about 5 inches above her knees, including go-go boots with 3 inch heels.
COMPLIANCE MET ON SITE- Ms. Ding put-on a black long length jacket.

Description: Licensees under this Chapter shall insure that all persons employed to work on the massage clinic premises, and including all massage technicians conducting licensed activities on the massage clinic premises, shall be dressed in clothing made of an opaque material, and at a minimum, shall not expose the technician's undergarments or bare midriff, or any specified anatomical areas, and shall comply with the following requirements, as applicable:

- (A) All garments covering the upper torso (e.g., shirts or dresses) shall have sleeves not less than two inches in length, measuring from the top of the shoulder, and necklines no lower than two inches below the clavicle.
- (B) Hems of dresses, skirts, smocks, or other similar garments shall not be more than two inches above the top of the knee.
- (C) Cuffs or hems of shorts, culottes, pants or other similar garments shall not be more than six inches above the top of the knee.

21A061 Linens - Storage

Inspector Comments: OBSERVATION: Towels & Linens were stored in an opened cabinet.
(A061-Linens-Storage)
COMPLIANCE MET ON SITE: Operator placed towels & linens in closed cabinet.

Description: Closed cabinets shall be utilized for the storage of clean towels and linen. After use, towels and linen shall be removed from the room or booth and stored in a clean container until laundered.

21A241 Structure - Adequate Lighting

Inspector Comments: OBSERVATION: The far East Room was not illuminated. Ms. Ding stated that the light bulb in the room burned out-(A241 Structure-Adequate Lighting).
COMPLIANCE REQUIREMENT: Within 5 days, install at least 60 watts of artificial light in the far East room.

Description: Minimum lighting shall be provided in accordance with the Uniform Building Code as adopted by the County. In addition, at least one unobstructed artificial light, white in color, of not less than 60 watts shall be provided and used at all times in each enclosed room or booth while massage services are being rendered.

21A242 Permit - License

Inspector Comments: OBSERVATION: The California Therapist Certification documentation was not on display.(A242-Permit License).
COMPLIANCE REQUIREMENT: Obtain and display the California Therapist Certification document.

Description: Each massage technician providing services at the clinic must display his or her County issued massage technician license or state issued certificate wherever he or she provides massages for compensation.

Overall Inspection Comments

The owner/ operator Fenyu Ding consented to the inspection.

Documentation:

DHS permit was on display. Permit expires 12/31/2016.

The California Massage Therapist Certification was not on display. Fenyu Ding produced a document noting that she passed the Massage Therapist examination on 12/20/2015. Ms Ding stated that the Massage Therapist Certified will arrive in the mail soon.
