Violation Description: A person who prepares or packages cottage food products shall obtain food worker certification within three (3) months of becoming registered/permited.

Inspector Comments: Ensure gross annual sales for 2014 do not exceed \$45,000.

Violation Description: A cottage food operation may not exceed allowable gross annual sales.

Overall Inspection Comments

Operator will be making chocolates, candies and carmel pretzels. All food shall be prepared, handled, baked, and packaged within the home kitchen.

Label was not available on site during the inspection.

Operator stated that she has 2 outside dogs. Ensure pets are not in the kitchen during cottage food preparation.

Operator has 2 children ages 18, 16, and 8. Ensure small and infants are not present in the kitchen during cottage preparation.

Ensure no domestic activities are conducted while preparing, handling or packaging any cottage food items.

Ensure no cottage food items are made if any illnesses are present.

Operator and family members stated they do not smoke within the home.

Ensure all equipment and utensils are in good repair and are washed, rinsed, sanitized and allowed to air dry prior to use.

No insects or rodents were observed at the time of inspection.

Operator had the incorrect food handlers card. Operator will be obtaining a San Bernardino County food handlers card.

AB1616 Cottage Bill handout was left on site.

Operator stated the gross annual sales for last year totaled \$300.

If owner/operator decides to sell food items at Farmers market or at a store with over 25 sq ft food products separate permits shall be required.
