**Inspector Comments:** Sample label did not contain business name, county of issuance, permit number, net weight, the words "made in a home kitchen," and full address. If the business name is in a public directory then labels may contain only the city, state and zip code. Ensure all food items are properly labeled.

**Violation Description:** A cottage food operation shall properly label all cottage food products. The words "Made in a Home Kitchen" shall be on the food product's primary display panel.

**32K018 Gross annual sales limit**

**Inspector Comments:** Ensure gross annual sales do not exceed \$45,000 for the year of 2014.

Operator will be making dry baking mixes, herb blend mixes, and candies. All food shall be prepared, handled, baked, and packaged within the home kitchen.

Operator has 1 employee named Shelli Pickens.

Operator stated that she has 3 outside and inside dogs. Ensure no pets are present during preparation of cottage food items.

Operator has two children ages 15 and 26 within the home. Ensure small and infants are not present in the kitchen during cottage preparation.

Ensure no domestic activities are conducted while preparing, handling or packaging any cottage food items.

Ensure no cottage food items are made if any illnesses are present.

Operator and family members stated they do not smoke.

Ensure all equipment and utensils are in good repair and are washed, rinsed, sanitized and allowed to air dry prior to use.

No insects or rodents were observed at the time of inspection. Operator is an exterminator. She services her home at least monthly.

Approved food list and sample label was left on site.

If owner/operator decides to sell food items at Farmers market or at a store with over 25 sq ft food products separate permits shall be required.
