Observed employee washing /rinsing /sanitizing dishes at front 3 compartment sink. Observed same employee allowing dishes to rest in sanitizer solution (chlorine) for less than 30 seconds. Observed chlorine sanitizer concentration above 200 ppm at front hand sink sanitizer bucket. Maintain chlorine sanitizing solution at 100ppm.

Observed ice scoop handle resting directly on top of ice. Corrected on site. Observed pizza trays resting directly on top of trash can. Discontinue this practice. Prevent all forms of potential cross contamination.

POINTS 1	Compliance date not specified	Inspector Comments: Provide a thermometer inside reach in unit (next to pizza oven and steam table). Ensure proper monitoring of cold holding equipment.

Violation Description: An accurate easily readable metal probe thermometer suitable for measuring temperature of food shall be available to the food handler. A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)
