21A011 Employee - Dress/Attire

Reference - SBCC - 41.1908(b)(11)

Inspector Comments: Observed staff wearing plunging neckline blouse.

Owner must remind staff to wear proper garments as per policy requirements.

Description: Licensees under this Chapter shall insure that all persons employed to work on the massage clinic premises, and including all massage technicians conducting licensed activities on the massage clinic premises, shall be dressed in clothing made of an opaque material, and at a minimum, shall not expose the technician's undergarments or bare midriff, or any specified anatomical areas, and shall comply with the following requirements, as applicable:

(A) All garments covering the upper torso (e.g., shirts or dresses) shall have sleeves not less than two inches in length, measuring from the top of the shoulder, and necklines no lower than two inches below the clavicle.

(B) Hems of dresses, skirts, smocks, or other similar garments shall not be more than two inches above the top of the knee.

(C) Cuffs or hems of shorts, culottes, pants or other similar garments shall not be more than six inches above the top of the knee.

21A060 Sanitation - Clean Linens

Inspector Comments: Observed unclean bed linens.

Owner must maintain to use only clean and sanitary towels and linens and maintain on a routine schedule.

Description: Clean and sanitary towels and linens shall be provided for patrons receiving massage services. No common use of towels or linens shall be permitted.

21A204 Permit - License

Inspector Comments: Observed lack of health permit license displayed in a conspicuous place.

Owner must obtain a health permit license and display in a conspicuous place and maintain on a routine schedule.

Description: Any massage clinic license issued by the County shall be displayed in a conspicuous place within view of customers.

21A242 Permit - License

Not In Compliance

Reference - SBCC - 41.1908(b)(13)

Inspector Comments: Observed lack of health permit license card for the massage technician.

Owner must secure that each massage technician has a valid and unexpired health permit license card and maintain on a routine schedule.

Description: Each massage technician providing services at the clinic must display his or her County issued massage technician license or state issued certificate wherever he or she provides massages for compensation.
