21A011 Employee - Dress/Attire

Reference - SBCC - 41.1908(b)(11)

Inspector Comments: Observed staff wearing strap (string type) blouse.

Owner must remind staff to wear proper garments as per policy requirements and maintain on a routine schedule.

Description: Licensees under this Chapter shall insure that all persons employed to work on the massage clinic premises, and including all massage technicians conducting licensed activities on the massage clinic premises, shall be dressed in clothing made of an opaque material, and at a minimum, shall not expose the technician's undergarments or bare midriff, or any specified anatomical areas, and shall comply with the following requirements, as applicable:

(A) All garments covering the upper torso (e.g., shirts or dresses) shall have sleeves not less than two inches in length, measuring from the top of the shoulder, and necklines no lower than two inches below the clavicle.

(B) Hems of dresses, skirts, smocks, or other similar garments shall not be more than two inches above the top of the knee.

(C) Cuffs or hems of shorts, culottes, pants or other similar garments shall not be more than six inches above the top of the knee.

21A061 Linens - Storage

Inspector Comments: Observed towels and linens in an open storage cabinet (covered with curtain).

Owner must have all the towels and linens in a clean and closed cabinet and maintain on a routine schedule.

Description: Closed cabinets shall be utilized for the storage of clean towels and linen. After use, towels and linen shall be removed from the room or booth and stored in a clean container until laundered.

21A204 Permit - License

Inspector Comments: Observed expired health permit license issued by the San Bernardino County.

Owner must obtain copy of the health permit license from San Bernardino County, be displayed in a conspicuous location, and maintain on a routine schedule.

Description: Any massage clinic license issued by the County shall be displayed in a conspicuous place within view of customers.

21A207 Structure - Signage

Comply by: 12/19/2016

Not In Compliance

Reference - SBCC - 41.1908(b)(1)

Inspector Comments: Observed lack of business name sign outside the establishment (only stating massage not Jade Spa).

Owner must post the business name sign outside the establishment and if it needs to be change refer to Building and Safety Department for requirements and maintain on a routine schedule.

Description: A readable sign shall be posted at the main entrance identifying the establishment as a massage clinic, provided, however, that all such signs shall otherwise comply with the sign requirements of the County Code.

21A240 Structure - Water

Inspector Comments: Observed lack of hot water on one of the bathroom sink.

Owner must provide a hot and cold running water and maintain on a routine schedule.

Description: Hot and cold running water shall be provided.
