Inspector Comments: Observed unclean bed linens. Owner must maintain to use only clean and sanitary towels and linens and maintain on a routine schedule.

Description: Clean and sanitary towels and linens shall be provided for patrons receiving massage services. No common use of towels or linens shall be permitted.

Overall Inspection Comments

Observed unclean shower room and used bar soap.

Owner must clean and disinfect regularly toilet and washroom facility and maintain on a routine schedule.

Owner must not use any bar soap for hand washing and only provide/use liquid soap in pump dispenser and maintain on a routine schedule.
