

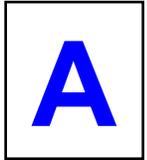

POINTS 4	Compliance date not specified Not In Compliance	Inspector Comments: Observed several flies at grill line. Observed 2 flies walking on trays and paper liner stored on counter above refrigerators. Eliminate vermin from facility.
	Violation Reference - HSC - 114259.1, 114259.4, 11425	

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

POINTS 2	Compliance date not specified Not In Compliance	Inspector Comments: When questioned on cleaning procedures of shake spindle, manager stated it is rinsed in sanitizer solution periodically and cleaned completely at the end of the night. When equipment contacts potentially hazardous foods, surface must be washed, rinsed and sanitized at least once every 4 hours. Provide training to employees on proper cleaning procedure mentioned above.
	Violation Reference - HSC - 113947-113947.1	

Violation Description: All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

7. PROPER HOT AND COLD HOLDING TEMPERATURES

POINTS 2	Compliance date not specified Not In Compliance	Inspector Comments: Measured container of sliced tomatoes holding at 44-45F and one container of chopped, hardboiled egg at 42-43F in cold pans above reach in refrigerator of salad station. Maintain all potentially hazardous foods in cold holding at 41F or below.
	Violation Reference - HSC - 113996, 113998, 114037	

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Violation Description: This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
