Description: Clean and sanitary towels and linens shall be provided for patrons receiving massage services. No common use of towels or linens shall be permitted.

21A204 Permit - License

Comply by: 3/19/2016

Inspector Comments: Massage County license/permit must be posted in area view of customers.

Not In Compliance

Reference - SBCC - 41.1908(b)(12)

Description: Any massage clinic license issued by the County shall be displayed in a conspicuous place within view of customers.

21A207 Structure - Signage

Comply by: 3/19/2016

Inspector Comments: A readable sign shall be posted at the main entrance and identify the facility.

Not In Compliance

Reference - SBCC - 41.1908(b)(1)

Description: A readable sign shall be posted at the main entrance identifying the establishment as a massage clinic, provided, however, that all such signs shall otherwise comply with the sign requirements of the County Code.
