This facility is currently in violation with the food safety certification requirement for San Bernardino County(SBC), which requires that at least one person obtain a valid food safety certificate within sixty (60) days of employment (California HSC §113947.1). Failure to provide proof of food safety certification within sixty (60) days may result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.</p> <p>Ensure that person has a food safety certificate. The original food safety certificate must be maintained in the facility at all times. Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

Maintain a list of food handlers and expiration dates for their cards for inspections.</p>

Violation Description: This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
