Description: Clean and sanitary towels and linens shall be provided for patrons receiving massage services. No common use of towels or linens shall be permitted.

Inspector Comments: Observed clean towels/linens stored in open shelves inside all massage rooms. Immediately provide closable cabinets in massage rooms for the storage of clean towels and linens.

Description: Closed cabinets shall be utilized for the storage of clean towels and linen. After use, towels and linen shall be removed from the room or booth and stored in a clean container until laundered.
