Operator makes baked goods (banana and carrot cake). Operator plans to conduct direct sales out of farmers markets and indirect sales out of local businesses. All food preparation, handling, baking, and packing will be conducted in the home kitchen.

Products for making bakery items are stored separately from household food items.

Operator stated that she has no employees.

If gross annual sales exceeds \$50,000, please contact DEHS to obtain a commercial kitchen permit.

Neither operator nor family members smoke.

Operator does not contract with a pest control service since she does not have vermin activity. No vermin observed during inspection.

Operator does not have any animals.

Operator has small children in the home. Ensure small children are not present during food preparation.

No preparation of food is to occur when illness is present in household.

No preparation of food is to occur when conducting other domestic activities.

All food contact surfaces shall be washed, rinsed, sanitized, and allowed to air dry.

If operating a Temporary Food Facility at an approved community event and food display area exceeds 25 square feet, an additional Temporary Food Facility permit will be required. Samples must be prepackaged, no slicing of samples can be conducted without a Temporary Food Facility permit.

If you plan to conduct sales in any other counties, please contact those health departments for operating requirements.
