POINTS 2	Compliance date not specified Complied on 5/17/2016 Violation Reference -	Inspector Comments: Observed no paper towel at the hand washing dispenser. Operator corrected on site by refilling the dispenser. Paper towel dispensers are to be fully stocked at all times.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

34. WAREWASHING FACILITIES: INSTALLED, MAINTAINED, USED; TEST STRIPS

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114067(f,g), 114099	Inspector Comments: Observed no sanitizer testing strip in the facility. Quaternary ammonium sanitizer was observed with a concentration of 200 ppm when tested at the three compartment sink using inspector's quaternary ammonium strip. Sanitizer testing equipment such as chlorine and quaternary ammonium testing strips are to be available in a food facility at all time to verify proper sanitizer concentration.

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

Discontinue this practice. Store all wiping cloth in sanitizer bucket with proper sanitizer concentration between uses at all times.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)
