**Inspector Comments:** During routine inspection on 10-1-15, 5 food handler cards were missing. Facility was granted to 14 days to comply with the requirement.

During billable reinspection on 10-28-15, observed 5 food handler cards still missing. Facility has been granted an addition 7 days to provide the food handler cards to EHS via fax. If food handler cards are not received by this date (11-4-15), additional billed reinspection will occur until compliance is met.

**Description:** During your last routine inspection, it was noted that your facility was in violation of the food handler certification requirement for San Bernardino County. Since the inspection, food handler certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.
