<b>POINTS</b> <b>2</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed roll of paper towels not stored in a dispenser at hand wash sink in kitchen and bar area. Store paper towels in a dispenser.
	Not In Compliance Violation Reference -	

Observed no splash guard between handwashing sink and 3 compartment sink at bar. Handwashing sink must be separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation.

**Violation Description:** Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

**34. WAREWASHING FACILITIES: INSTALLED, MAINTAINED, USED; TEST STRIPS**

<b>POINTS</b> <b>1</b>	Compliance date not specified	<b>Inspector Comments:</b> Observed automatic sanitizer dispenser providing quaternary ammonia solution between 100-200 ppm. Repair/replace dispensing unit so that quaternary ammonia solution is dispensed at least at 200 ppm.
	Not In Compliance Violation Reference - HSC - 114067(f,g), 114099	

**Violation Description:** Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

	Not In Compliance Violation Reference - HSC - 114074, 114081, 114119	

Observed tray of raw, shelled eggs stored over clean drinking cups. Store drinking cups in a location that prevents possible contamination of lip contact surfaces.

**Violation Description:** All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

**48. FOOD HANDLER CERTIFICATION**

Fax missing food handler card form within 14 days to avoid a future charged follow-up inspection at an hourly rate of \$245. **Violation Description:** This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
