Description: Instruments used for massage shall be disinfected prior to each use by a reasonable method approved by the EHS. Where such instruments for massage are employed, adequate quantities of supplies for disinfection shall be available during all hours of operation.

Immediately remove all unapproved and not easily cleanable liners from all massage tables.

Inspector Comments: Observed clean towels stored on top of toilet tank inside the ladies restroom.
Discontinue storing towels at the previously mentioned area and provide closed cabinets for towel storage.
The towels were removed by the employee at time of inspection.

Description: Closed cabinets shall be utilized for the storage of clean towels and linen. After use, towels and linen shall be removed from the room or booth and stored in a clean container until laundered.
