RESOLUTION NO. 10-03

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ADELANTO, CALIFORNIA, SUPPORTING THE APPLICATION BY THE CITY OF VICTORVILLE TO EXPAND ITS SPHERE OF INFLUENCE.

WHEREAS, the City of Victorville has made application to the Local Agency Formation Commission (LAFCO) to expand its Sphere of Influence; and

WHEREAS, the City of Adelanto has agreed to assist the City of Victorville in creating a buffer for land use compatibility around the Southern California Logistics Airport which involves a change in boundaries for both the City of Adelanto and the City of Victorville; and

WHEREAS, the City of Adelanto and the City of Victorville have met and the City of Adelanto has agreed to the detachment of approximately 800 acres in the Northeast section of Adelanto (map attached) in exchange for financial assistance for intersection improvements at major intersections along Highway 395 from Mojave Drive north and road improvements to Adelanto Road from its beginning at Highway 395 north to Colusa Road and Rancho Road from Adelanto Road west to Highway 395 and allowing the detached area to be placed into the Sphere of Influence for the City of Victorville; and

WHEREAS, the City of Victorville is capable of serving the area and providing facilities which meet or exceed the current services available; and

WHEREAS, the LAFCO has requested a Resolution of Support for the expansion of the City of Victorville Sphere of Influence from the City of Adelanto.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ADELANTO, CALIFORNIA, DOES HEREBY RESOLVE, DECLARE, DETERMINE, AND ORDER AS FOLLOWS:




