**CITY OF ADELANTO SPHERE OF INFLUENCE REDUCTION
and
CITY OF VICTORVILLE SPHERE OF INFLUENCE EXPANSION**

LEGAL DESCRIPTION

That portion of Section 35 and Section 36, Township 7 North, Range 5 West, San Bernardino Meridian, lying West of the centerline of the Mojave River, in the County of San Bernardino, State of California, within the following described boundary:

Beginning at the Southwest corner of said Section 35, said corner being in the existing Northerly boundary line of the City of Victorville as established by LAFCO 2833 CITY OF VICTORVILLE REORGANIZATION 1997-1, recorded August 20, 1998 as Document No. 19980337232 in the Official Records of Said County, and being in the existing Southerly boundary of the City of Adelanto as established by LAFCO 2858 – CITY OF ADELANTO ANNEXATION No. 99-01, recorded July 06, 2000 as Document No. 20000240398 in said Official Records;

1. Thence Northerly, coincident with the West line of said Section 35, leaving said existing Southerly boundary of the City of Adelanto and existing Northerly boundary of the City of Victorville, to the Northwest corner of said Section 35, said Northwest corner being in the Northerly line of the existing Northerly boundary of the City of Adelanto per said LAFCO 2858;
2. Thence Easterly, coincident with the North line of said Section 35 and Section 36 and said existing Northerly boundary line of the City of Adelanto per LAFCO 2858, to the centerline of Floreate Road as shown on Tract No. 8639 filed in Book 125 of Maps at Pages 35 through 41, in the Official Records of said County;
3. Thence continuing Easterly, coincident with said North line of Section 36, leaving said existing Northerly boundary of the City of Adelanto per LAFCO 2858, to the intersection of the centerline of the Mojave River;
4. Thence Southerly, coincident with said centerline of the Mojave River, to the South line of said Section 36; said South line being said existing Northerly line of the City of Victorville boundary per LAFCO 2833;
5. Thence Westerly, coincident with said South line of Section 36 and said Northerly boundary line of the City of Victorville per LAFCO 2833, to the centerline of said Floreate Road, said centerline being the existing boundary of the City of Adelanto per said LAFCO 2858;

6. Thence continuing Westerly, coincident with said South line of Section 36 and Section 35, said existing boundary of the City of Adelanto per LAFCO 2858, and said Northerly boundary of the City of Victorville per LAFCO 2832, to the Point of Beginning.

The area within the hereon described boundary is 920 acres more or less.
