In the County of San Bernardino, State of California, described as follows:

Commencing at a point in the existing City of Rialto boundary per Annexation No. 134, LAFCO No. 2169 per Certificate of Completion Recorded April 19, 1983 as Instrument No. 83-082922 said point being the intersection of said boundary and the northwesterly line of Lot 56 of the Semi-Tropic Land and Water Company per map recorded in Book 6 of Maps, Page 12, Records of San Bernardino County, California,

Thence South $44^{\circ} 43' 32''$ East along said City of Rialto boundary line a distance of 29.39' to the Point of Beginning, thence,

Course 1. North $36^{\circ} 27' 54''$ East, a distance of 44.50', thence,

Course 2. North $26^{\circ} 05' 25''$ East, a distance of 137.29', thence,

Course 3. North $37^{\circ} 35' 38''$ East, a distance of 63.44', thence,

Course 4. North $47^{\circ} 26' 20''$ East, a distance of 28.04', thence,

Course 5. North $75^{\circ} 15' 43''$ East, a distance of 32.64', thence,

Course 6. South $84^{\circ} 41' 56''$ East, a distance of 434.18', thence,

Course 7. South $84^{\circ} 14' 04''$ East, a distance of 453.86' to the beginning of a non-tangent curve concave to the southwest and having a radius of 99.47', a radial line through said point bears North $12^{\circ} 57' 04''$ East, thence,

Course 8. Southeasterly, along the arc of said curve through a central angle of $50^{\circ} 33' 54''$ a distance of 87.79', thence,

Course 9. South $64^{\circ} 08' 10''$ East, a distance of 20.59', thence,

Course 10. South $83^{\circ} 58' 21''$ East, a distance of 393.71', thence,

Course 11. South $36^{\circ} 35' 14''$ West, a distance of 957.45', thence,

Course 12. North $53^{\circ} 51' 29''$ West, a distance of 364.57', thence,

Course 13. South $35^{\circ} 52' 31''$ West, a distance of 73.43', thence,

Course 14. South 34° 08' 16" West, a distance of 7.91' more or less to the said City of Rialto Boundary, thence,

Course 15. North 55° 26' 26" West, along said boundary a distance of 211.64', thence,

Course 16. North 44° 43' 32" West, along said boundary a distance of 639.00' to the Point of Beginning.



