NOTICE OF INTENT TO CIRCULATE PETITION FOR A SPHERE OF INFLUENCE AMENDMENT & ANNEXATION TO THE CITY OF REDLANDS

Notice is hereby given of the intention to circulate a petition proposing a 1.55-acre of land located at the northwest corner of West Lugonia Avenue and Tennessee Street (APN: 0167-171-13-0000) (the "Property") for a Sphere of Influence Amendment and reorganization to Annex the westerly 0.38-acre portion of the parcel into the City of Redlands. The Landowner Hal Sears Revocable Trust dba HMS Properties, LP, hereby submit this application to initiate proceedings with the Local Agency Formation Commission for San Bernardino County and owner likewise requests that the Property be detached from the San Bernardino Fire Protection District and its Valley Service Area 70.

The legally uninhabited/vacant parcel is undeveloped and currently straddles the jurisdictional boundary line between the City of Redlands and the County of San Bernardino. The East Valley Corridor Plan is the current governing overlay zoning district in both jurisdictions and the property is zoned East Valley Special District (EVSD).

This unique jurisdictional situation is the result of a historical appeal on behalf of Majestic Development to de-annex from the City of Redlands in the late 1980's. Subsequent to the de-annexation, the dedication of right-of-way to construct Highway 30/Interstate 210 resulted in the physical separation of the subject parcel from Majestic Development's development known as Citrus Grove. Due to the configuration of the subject parcel, limited available access and proximity to regional roadway boundaries, the property is currently undevelopable. However, to proceed with any future development efforts, the subject land must be consolidated within a single governing entity.

The City of Redlands, the Local Agency Formation Commission for San Bernardino County (LAFCO) and Majestic Reality currently concur that the subject parcel rightfully should be annexed into the City of Redlands and rezoned to East Valley General Corridor General Commercial (EVGC). Subsequently, an Annexation Plat petition and a Sphere of Influence rezoning application have been processed by the City of Redlands to legally correct the split-jurisdictional condition as exhibited in the attached recorded Resolutions:

- Sphere of Influence Change & Annexation; Resolution No. 7770
- General Plan Amendment No.138; Resolution No. 7771
- Specific Plan Amendment No. 44; Resolution 7772
- Consolidation of Parcel Jurisdiction: Resolution 7890
