The City of Montclair actively provides park and recreation, storm drainage, sewer, roads, street sweeping, fire protection and emergency medical, library, and police services. The City operates with governmental funds and reports one major business-type fund: sewer maintenance. The City provides fire protection/emergency medical response within its sphere of influence, to the area of the former Monte Vista Fire Protection District, and receives an increased share of the property tax for that service responsibility. Water service is provided by the independent Monte Vista Water District. The City does not identify any debt related to business-type activities. 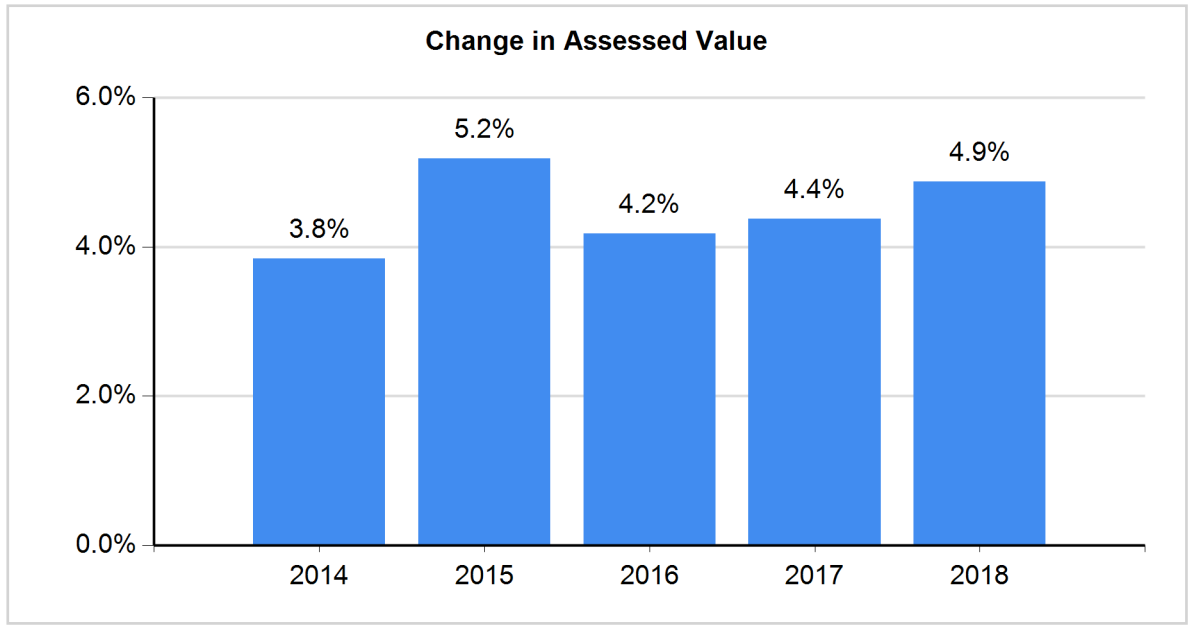
Change in Assessed Value

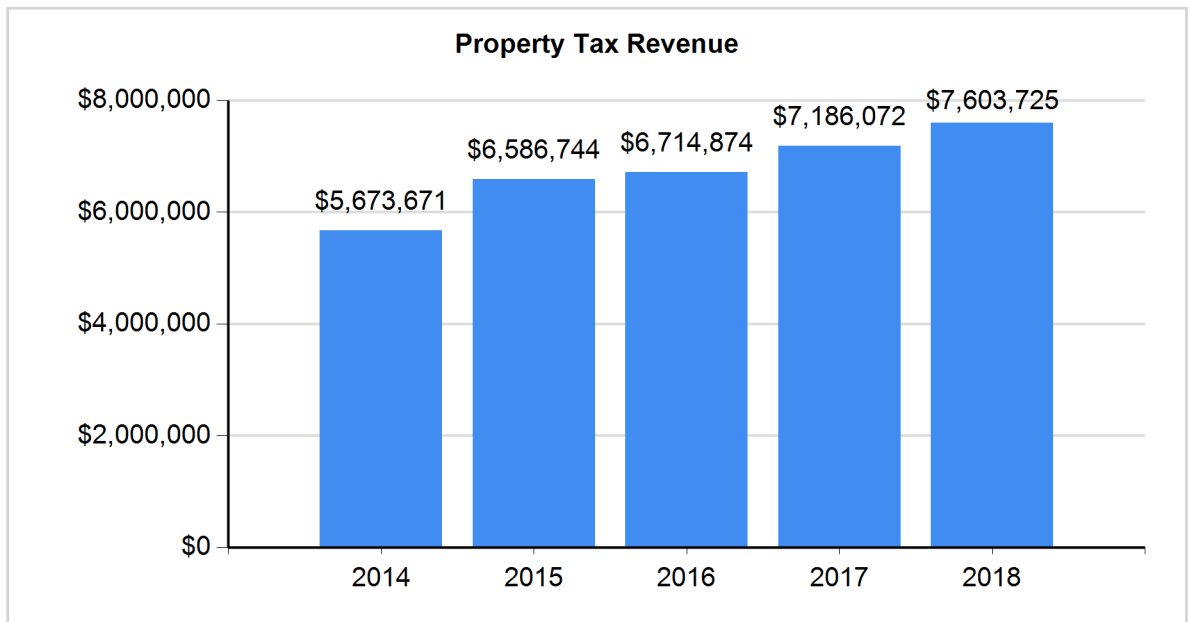
Property Tax Revenue

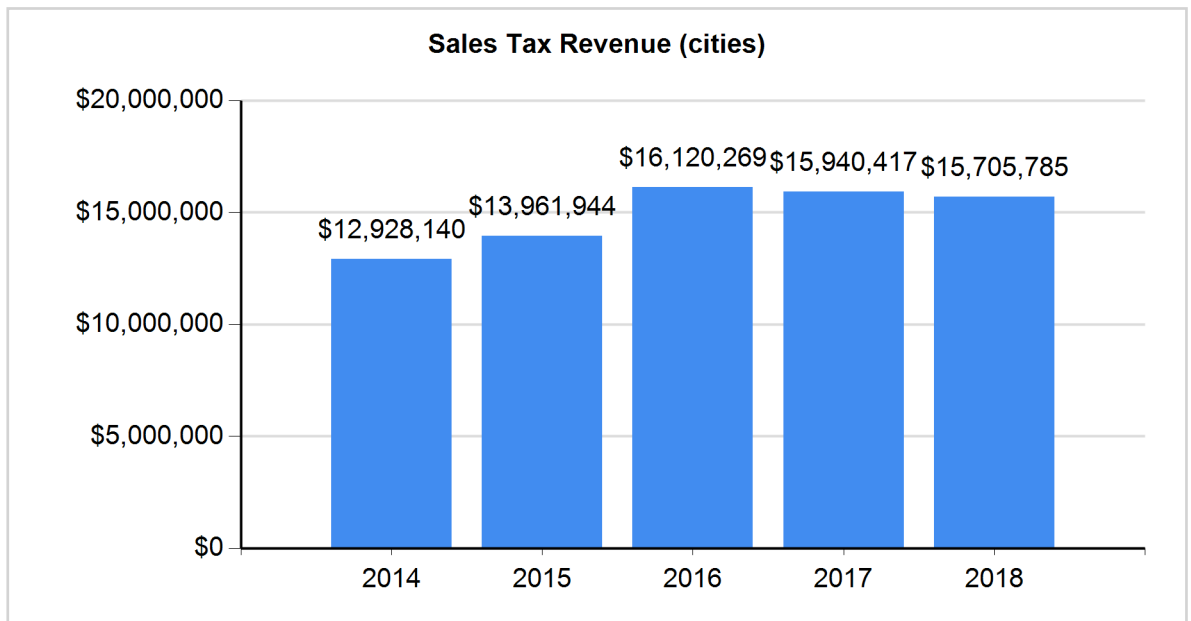
Sales Tax Revenue (cities)

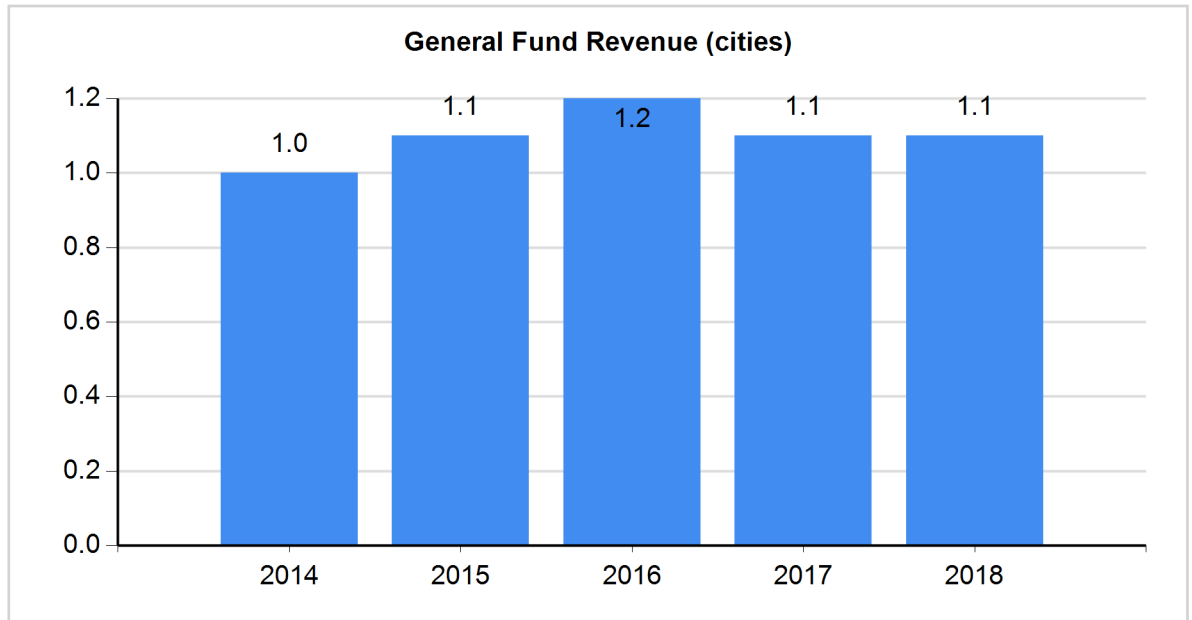
General Fund Revenue (cities)

Description

In most cases, as the percentage of general revenues decreases, a local government loses its ability to respond to changing conditions and to citizens' needs and demands. Decreases in general revenue may also indicate over-dependence on external revenues which are often restricted in nature and could signal future difficulty in maintaining service levels. A ratio of one or higher indicates that the service is self-supporting.

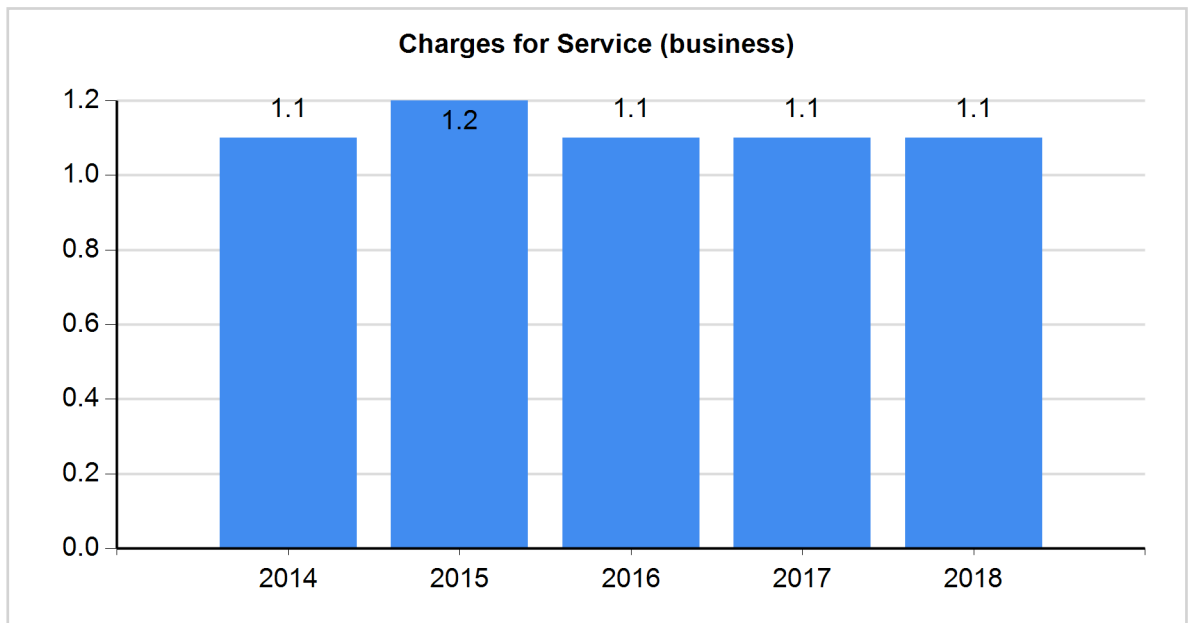
Charges for Service (business)

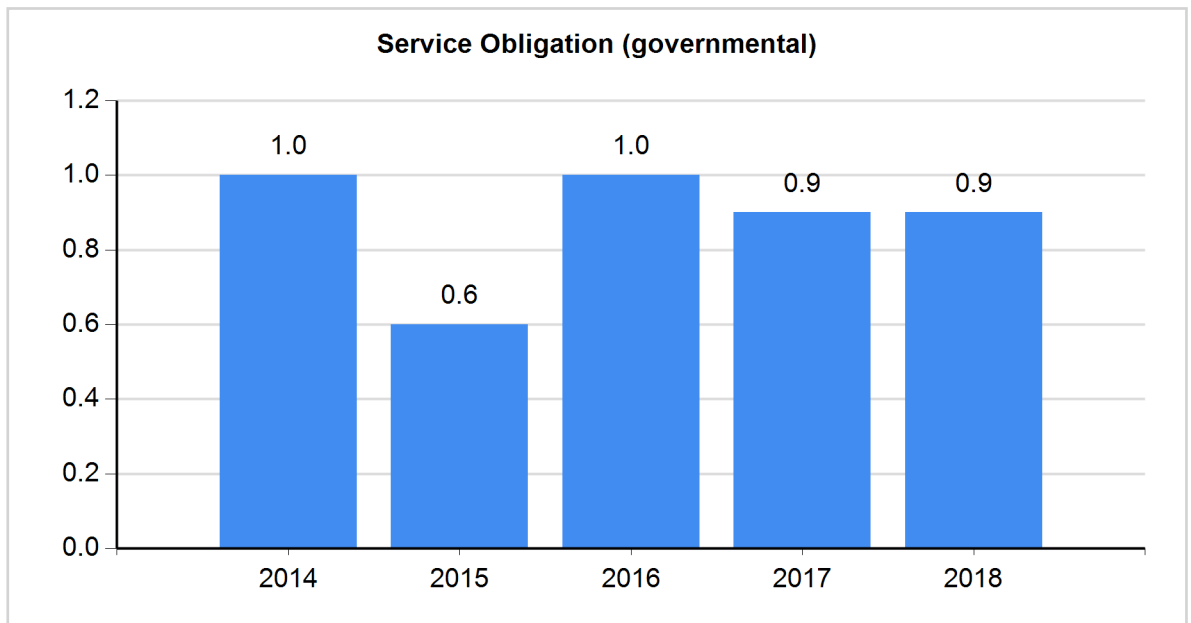
Service Obligation (governmental)

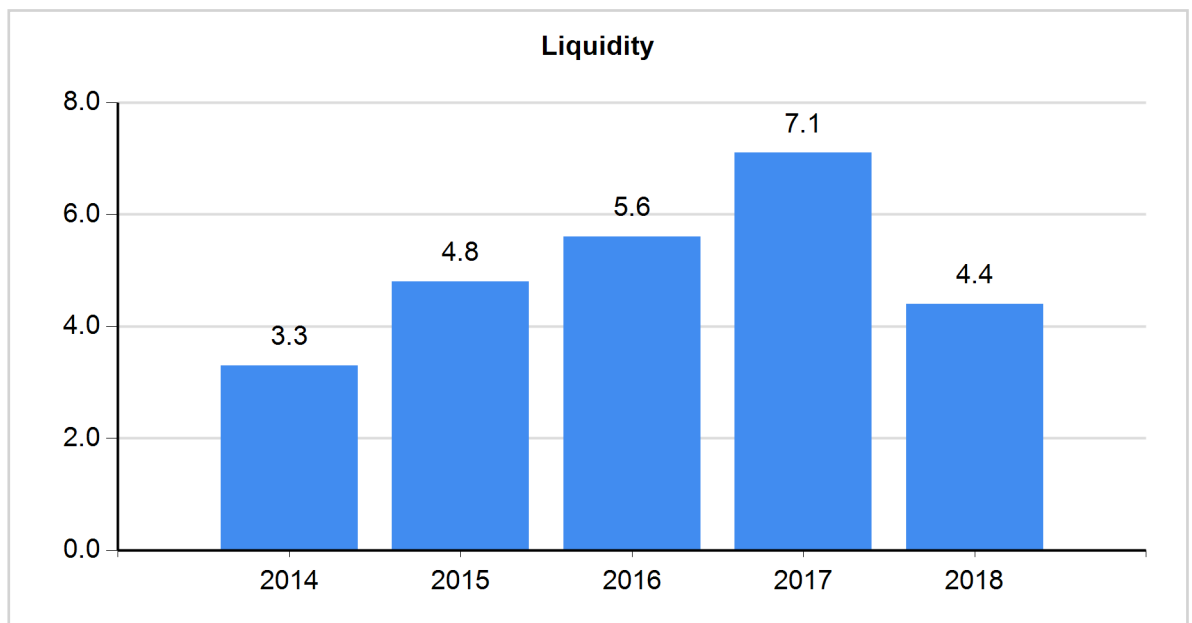
Liquidity

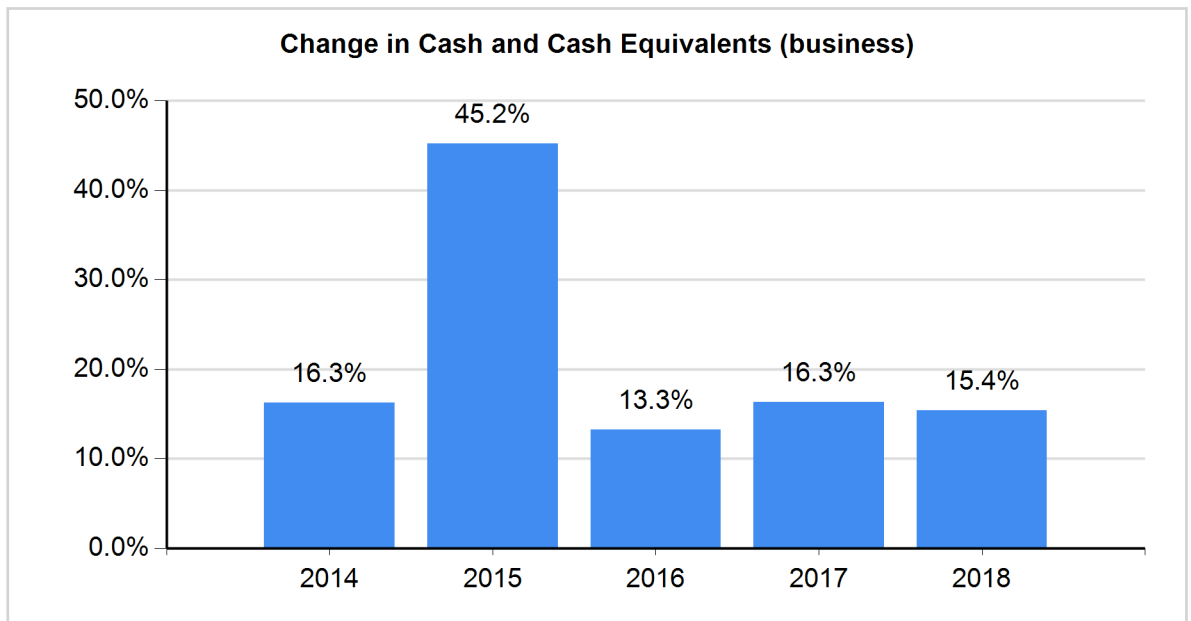
Change in Cash and Cash Equivalents (business)

Description

Cash and cash equivalents are the most liquid assets of an agency's assets and can be readily converted into cash. A positive percent change indicates that a government's cash position has improved.

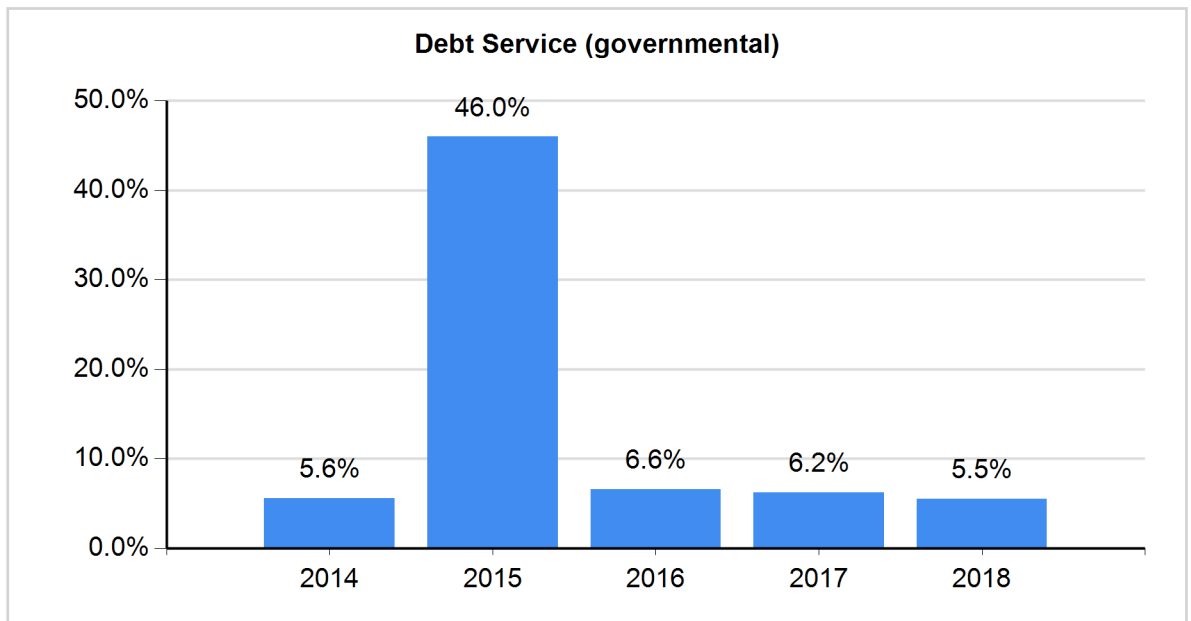
Debt Service (governmental)

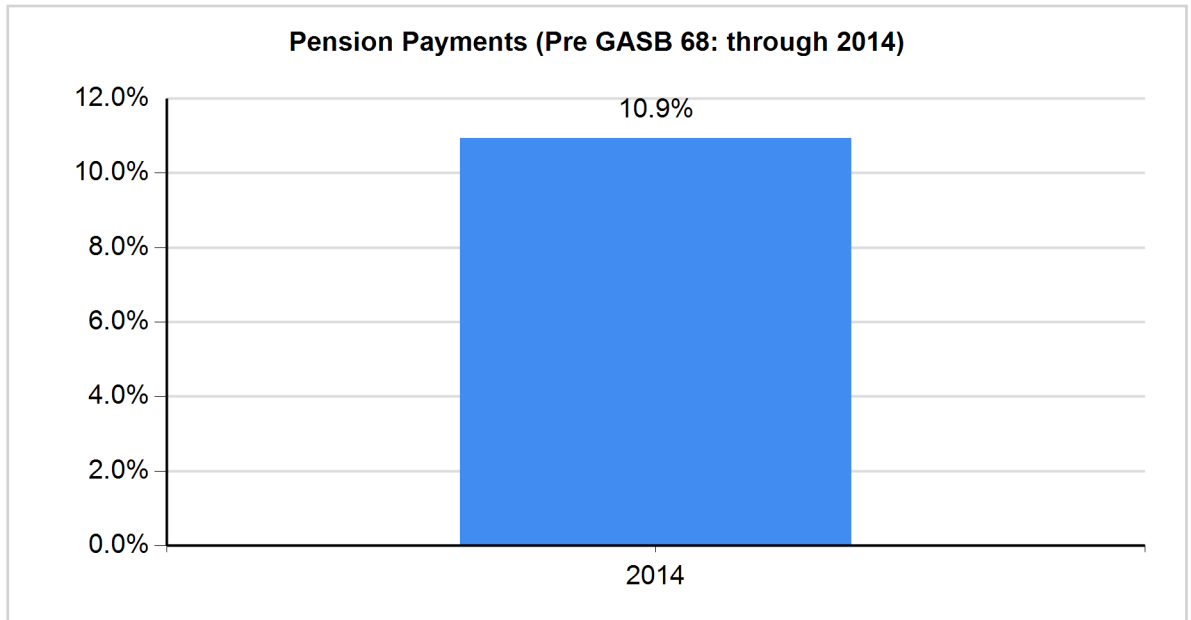
Pension Payments (Pre GASB 68: through 2014)

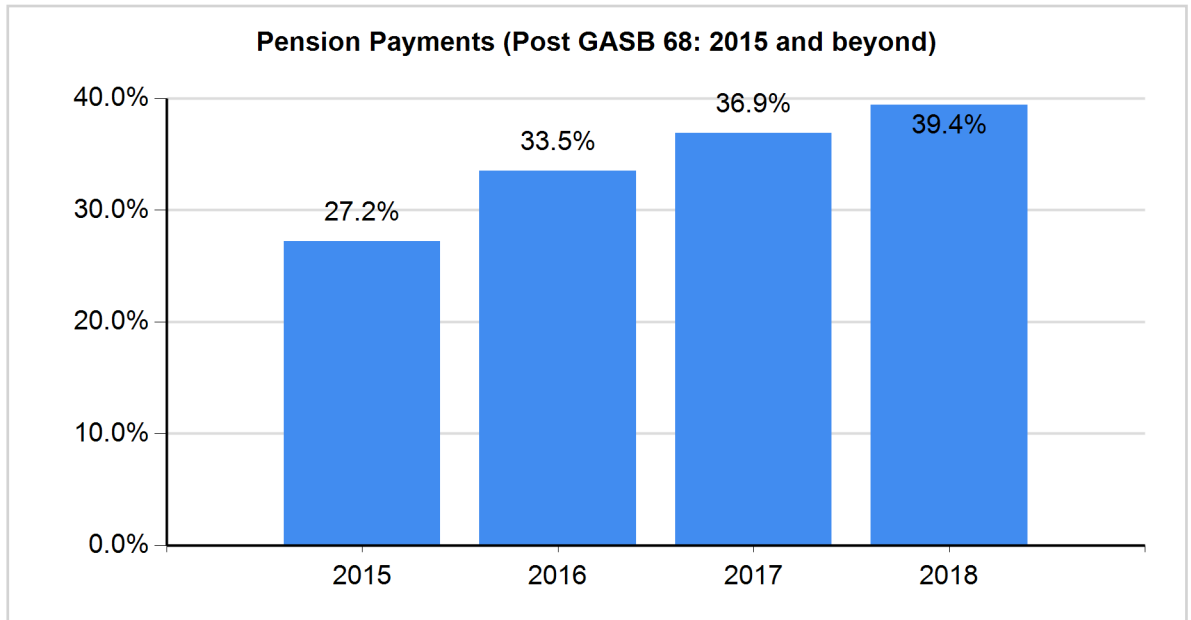
Pension Payments (Post GASB 68: 2015 and beyond)
