The Victorville Water District is authorized by LAFCO to provide the following function: water and sewer. Sewage treatment and disposal is provided by contract with the Victor Valley Wastewater Reclamation Authority as well as through its operation of its plant at Southern California Logistics Airport. The district is a self-governed subsidiary district of the City of Victorville, the city council is the ex-officio board of directors of the district (see link below). The Victorville Water district is a component unit of the City of Victorville. Water District pension is combined with the City. 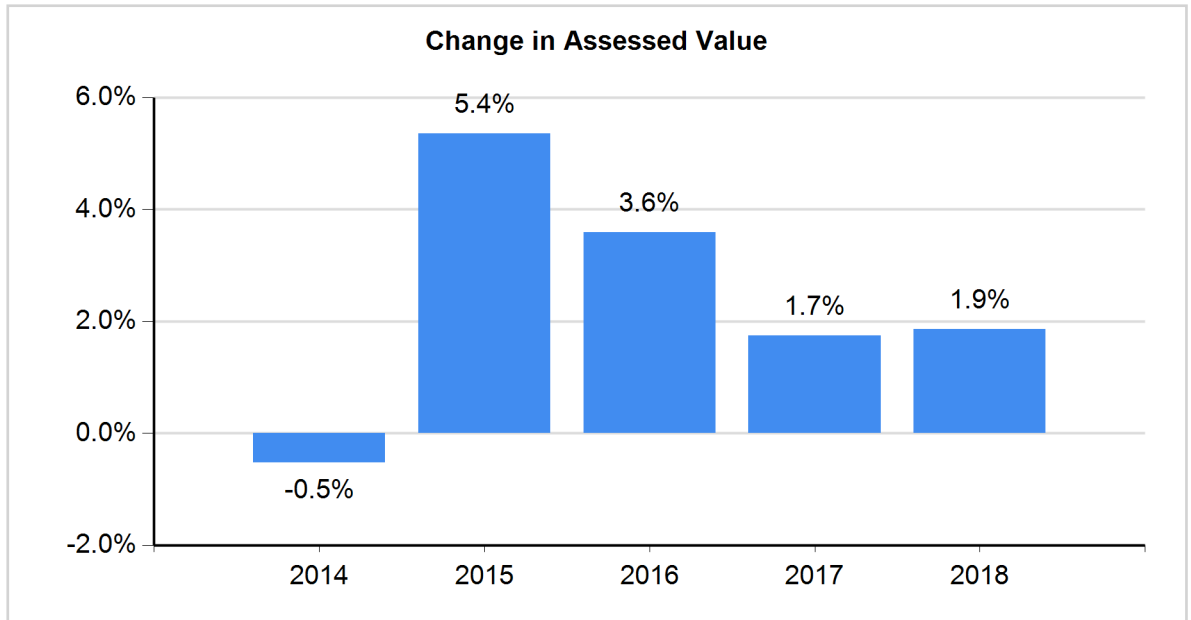
Change in Assessed Value

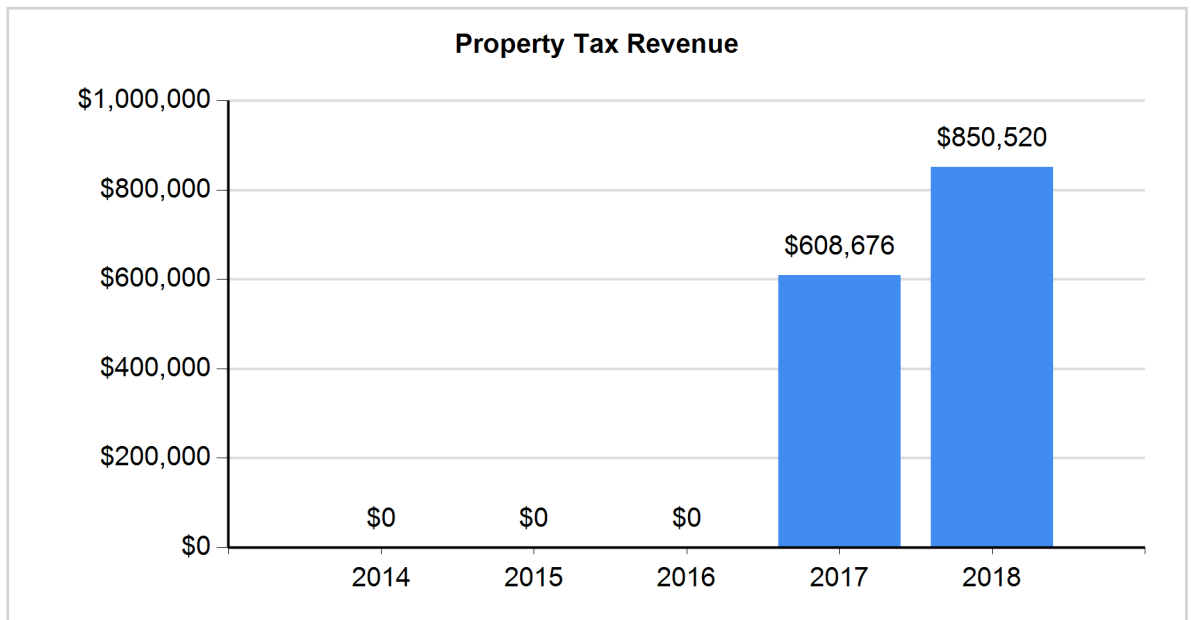
Property Tax Revenue

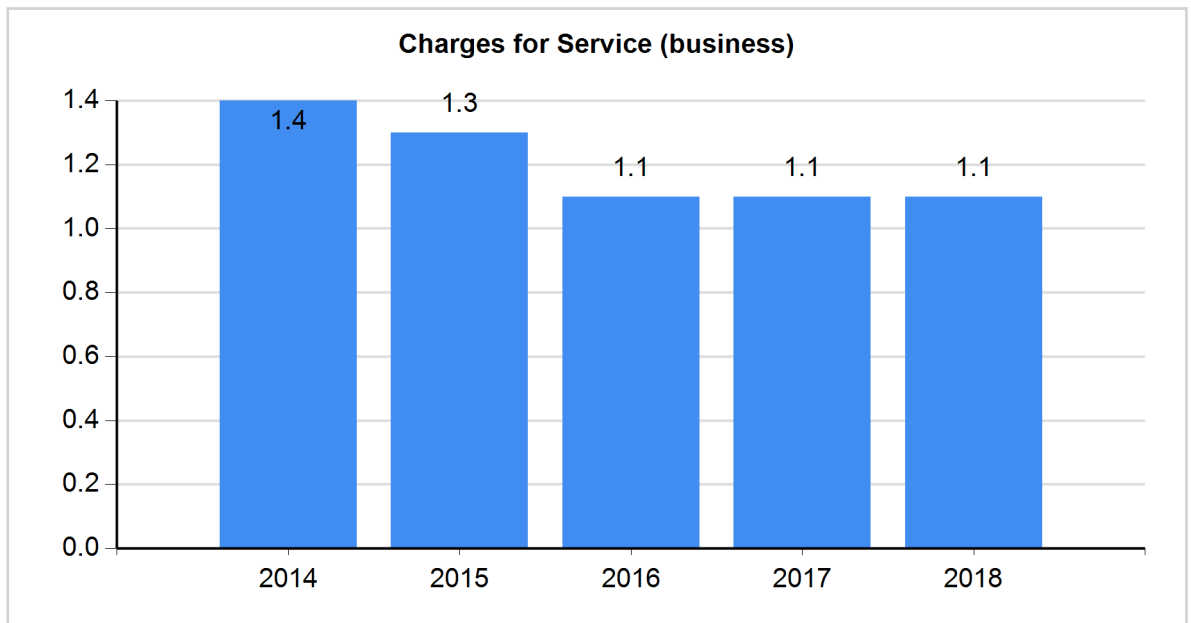
Charges for Service (business)

Description

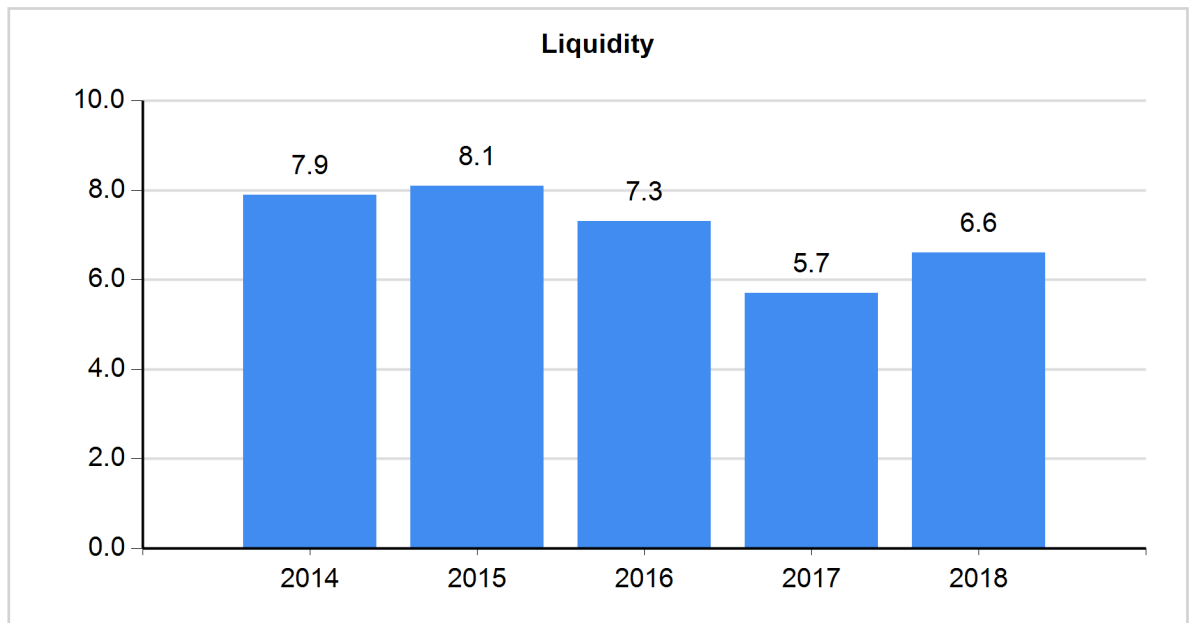
Measures a government's ability to meet its short-term obligations. A high ratio suggests a government is able to meet its short-term obligations.

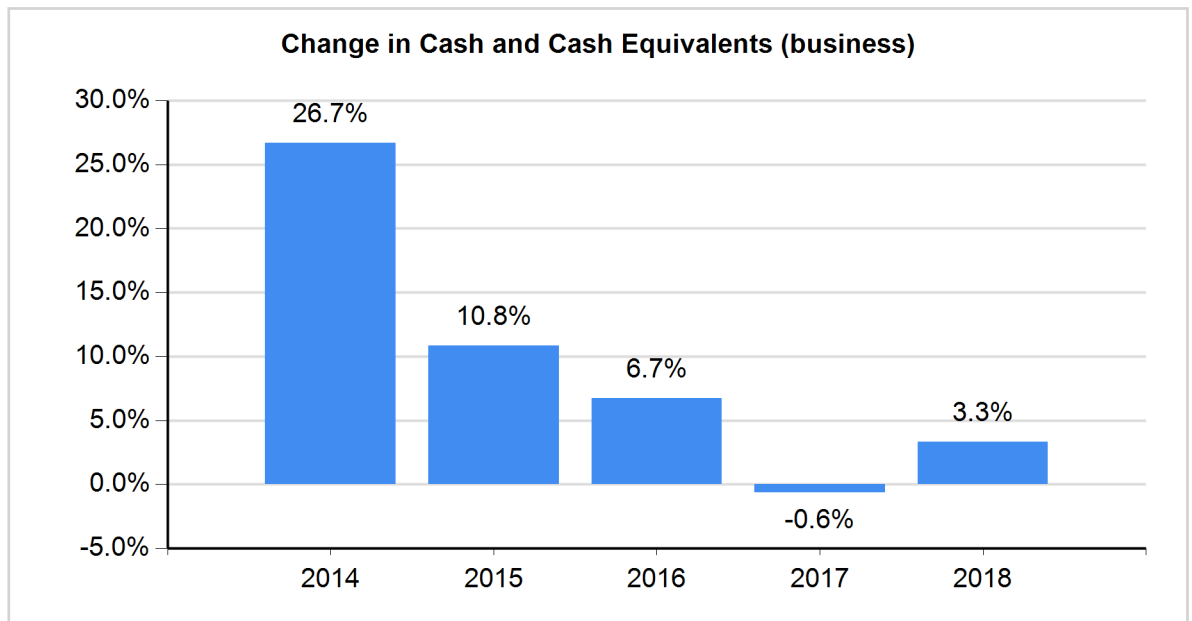
Change in Cash and Cash Equivalents (business)

Description

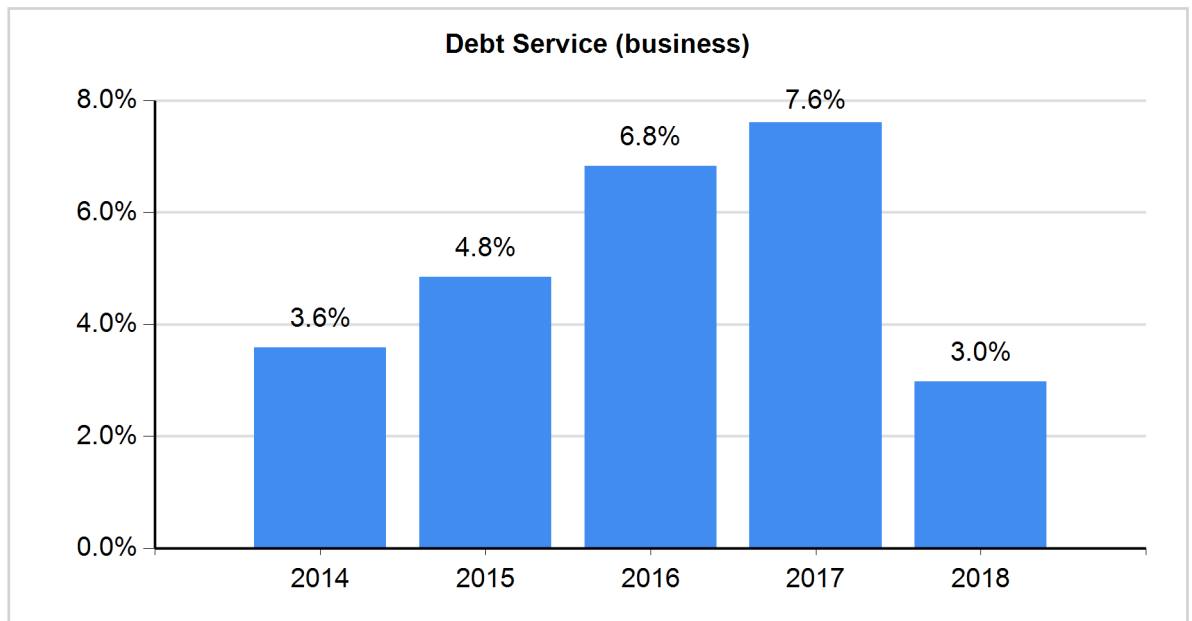
Looks at service flexibility by determining the amount of total expenses committed to annual debt service. Service flexibility decreases as more resources are committed to annual debt service.

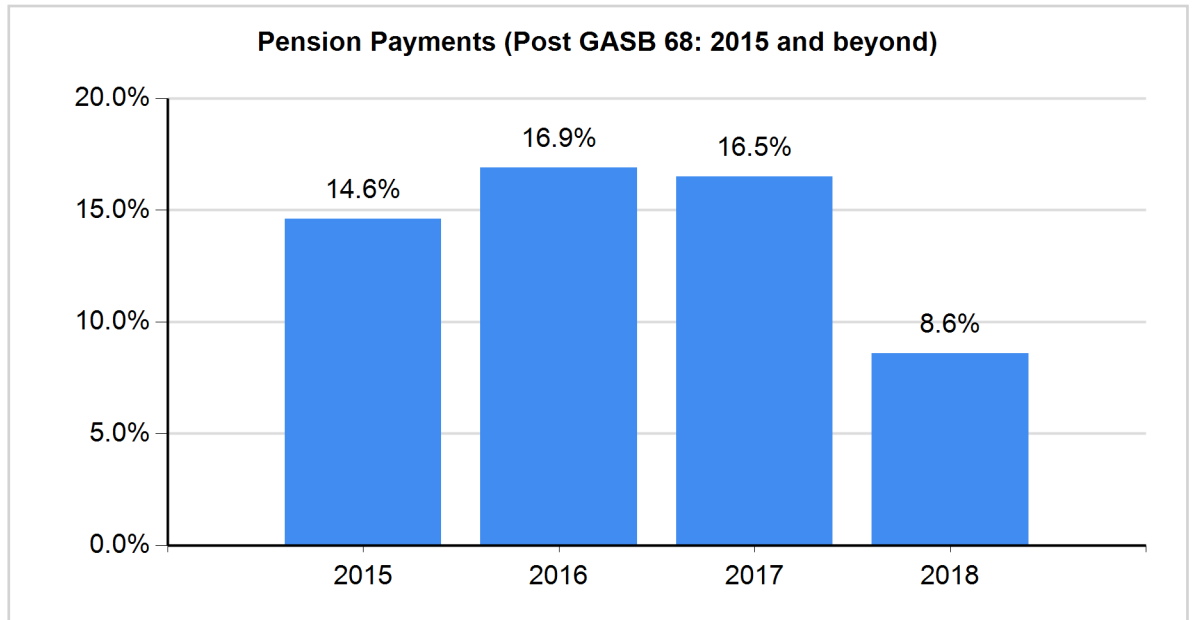
Pension Payments (Post GASB 68: 2015 and beyond)
