


At the May 16, 2012 Commission hearing, the service review and sphere of influence update hearing was conducted with a determination that a zero sphere of influence be assigned the District. At the June 20, 2012 hearing the Commission approved reconsideration of its previous determination for the service review and zero sphere of influence assignment. The service review/sphere of influence update study area encompasses approximately 650 square miles and is located in the south desert region of the County. The study area generally encompasses the Twentynine Palms (which includes the City of Twentynine Palms) and the Wonder Valley communities, including a portion of the Twentynine Palms Marine Corps Air Ground Combat Center.



8. Definition of Community and Service Review for Morongo Valley which includes the review of County Service Area 70 Zones F, W-3, and TV-2 and Golden State Water Company (Del Norte and Del Sur Systems); and,

Consideration of: (1) CEQA Statutory Exemption for LAFCO 3151; and (2) LAFCO 3151 – Service Review and Sphere of Influence Update for the Morongo Valley Community Services District

The service review and sphere study area is located in the south desert region of the County and is generally bordered by a combination of the east line of Range 3 East and section lines on the west; a combination of section lines, the Pipes Canyon Preserve Wilderness, and the Town of Yucca Valley on the north; a combination of the Town of Yucca Valley and the Joshua Tree National Park on the east; and the Riverside County line on the south. The boundary and/or sphere of influence include portions of the San Gorgonio Wilderness and the Big Morongo Canyon Preserve. LAFCO staff is recommending a sphere of influence expansion of approximately 8,130 acres to the west and northwest.
