

NOTICE OF PROTEST HEARING

LAFCO 3175 – REORGANIZATION TO INCLUDE ANNEXATIONS TO THE HELENDALE COMMUNITY SERVICES DISTRICT AND ANNEXATION TO ZONE FP-5 OF THE SAN BERNARDINO COUNTY FIRE PROTECTION DISTRICT

Notice is hereby given that a Protest Hearing will be held by the Executive Officer of the Local Agency Formation Commission (LAFCO) of San Bernardino County. The hearing will be held at the LAFCO Office at 215 N. "D" St., Suite 204, San Bernardino, California 92415-0490, on **May 21, 2014 at 2:00 p.m.**, to hear and receive any oral or written protests, objections, or evidence which are made, presented, or filed regarding LAFCO 3175.

The reorganization area encompasses 8,832+/- acres in total and includes three separate areas within the Helendale community.

Proceedings for this reorganization were initiated by the Helendale Community Services District and submitted to LAFCO. This proposal has been assigned the short-form designation of LAFCO 3175.

The proposed terms and conditions for this reorganization are set forth in LAFCO Resolution No. 3179 adopted by the Commission on March 19, 2014, which is available for review in the LAFCO office and on our website at: [Click here to view the staff report & attachments](#)

The reason for this proposal, as outlined by the Helendale Community Services District, is:

- a) To respond to landowner request.
- b) To plan responsibly for the future of the Helendale community.

Any owner of land within the territory proposed to be reorganized may file an official protest. Such protest must be made in writing and submitted to the LAFCO office prior to the conclusion of the hearing. The written protest must include your name, address, address of the land owned within the affected area if different from your residence, Assessor Parcel Number and LAFCO number. The written protest must be dated. Any protest without a date, bearing a date prior to the date of publication of this notice, or submitted after the conclusion of the hearing, shall be disregarded for purposes of ascertaining the value of any written protests. Protest cannot be accepted by fax or email.

Any registered voter residing within the territory proposed to be reorganized may file an official protest. Such protest must be made in writing and submitted to the LAFCO office prior to the conclusion of the hearing. The written protest must include your name and address as they appear on the affidavit of registration and the LAFCO number. The written protest must be dated.

Any protest without a date, bearing a date prior to the date of publication of this notice, or

submitted after the conclusion of the hearing, shall be disregarded for purposes of ascertaining the value of any written protests. Protest cannot be accepted by fax or email.
