RE: NOTICE OF AVAILABILITY FOR THE DRAFT ENVIRONMENTAL IMPACT REPORT FOR OMYA INC. WHITE KNOB/WHITE RIDGE LIMESTONE QUARRY EXPANSION PROJECT (State Clearinghouse Number 2013061020)

The Draft Environmental Impact Report (EIR) for the OMYA Inc. White Knob/White Ridge Limestone Quarry Expansion project is available for public review and comment. The purpose of the document is to identify and describe the probable environmental impacts that would result from the proposed project on approximately 375.1 acres. OMYA Inc. has proposed an Amended Mine and Reclamation Plan for expansion of the existing White Knob/White Ridge Limestone Quarries, located in the San Bernardino Mountains north of Lucerne Valley. The Amended Plan would increase the operational life of the quarry by 24 years from the existing permit expiration date of 2031 to the year 2055. The Amended Plan includes the existing White Knob Quarry and White Knob Annex, the approved White Ridge Quarry, the existing Overburden Site, the proposed Overburden Sites #2 and #3, and other ancillary disturbance areas, including haul roads and sediment basins. The post-mining use is proposed as open space and wildlife habitat. The project incorporates reclamation requirements of the Surface Mining and Reclamation Act of 1975 (SMARA) as well as the County's surface mining and land reclamation ordinance (County Code Section 88.03.000).

This document has been prepared to meet the State requirements of the California Environmental Quality Act (CEQA). The Draft EIR has been prepared under the supervision of the County of San Bernardino Land Use Services Department, and is being circulated to the public and interested agencies in accordance with CEQA and the CEQA Guidelines.
