In accordance with the California Environmental Quality Act (CEQA) and the CEQA Guidelines, County Staff prepared a Draft Initial Study / Negative Declaration (IS/ND) that identify and evaluate the environmental impacts of the Tentative Parcel Map described below.

Project Title: Tentative Parcel Map No. 19911

Project Location: The property is located between La Cadena Road and Fremontia Road, one lot south from Brawley Road.

Project Description: TENTATIVE PARCEL MAP (TMP) 19911 TO SUBDIVIDE 5.04 GROSS ACRES INTO TWO (2), 2.5-ACRE PARCELS WITHIN THE OAK HILLS COMMUNITY PLAN/RURAL LIVING (OH/RL) LAND USE ZONING DISTRICT; 1ST SUPERVISORIAL DISTRICT; APN: 3064-491-14; PROJECT NO.: P201800019.

The project site is currently vacant and consists of an approximately 5-acre parcel. The project lies within the unincorporated portion of the County of San Bernardino, west of Interstate 15, south of the California Aqueduct and north of the Union Pacific Railroad. The County's General Plan designates the project area as Oak Hills / Rural Living (OH/RL). The site is regulated by the FS-1 and Biotic Resource Overlay.
