
Based on information provided to us by you, it is our understanding that the scope of the proposed site development remains essentially unchanged. Furthermore, it is our understanding that the project

Environmental Impact report is currently undergoing review; the project is still conceptual in nature and has not entered the design phase.

We have spoken to Mr. Howard Brown, who has performed geologic mapping of the area and submitted the geologic review comments that were addressed in Reference No. 4. Mr. Brown indicated he submitted his geologic map to CGS and while it was approved by the agency, CGS has yet to officially publish the document. No new geologic or geotechnical data has become available for the area since issuance of Reference No. 4.

Based on these considerations, the geotechnical design recommendations presented in the referenced geotechnical reports and addenda remain applicable to the project as presently proposed with respect to regulations, geologic information, and impacts. When the project enters into the design phase, Geocon should be contacted to review the project plans and to provide updated recommendations in accordance with the California Building Code requirements in effect at that time.
