4.0 Special Presentation: Andy Wingert & Paul Kleinsmith from Code Enforcement made a presentation regarding short term rentals. They discussed the present status of the revised ordinance and answered questions from the public.

Murray gave a report on the upcoming Breakfast with your Supervisor, the Hwy 138 project beginning in September 2016, as well as an update on future Hwy 330 projects.
