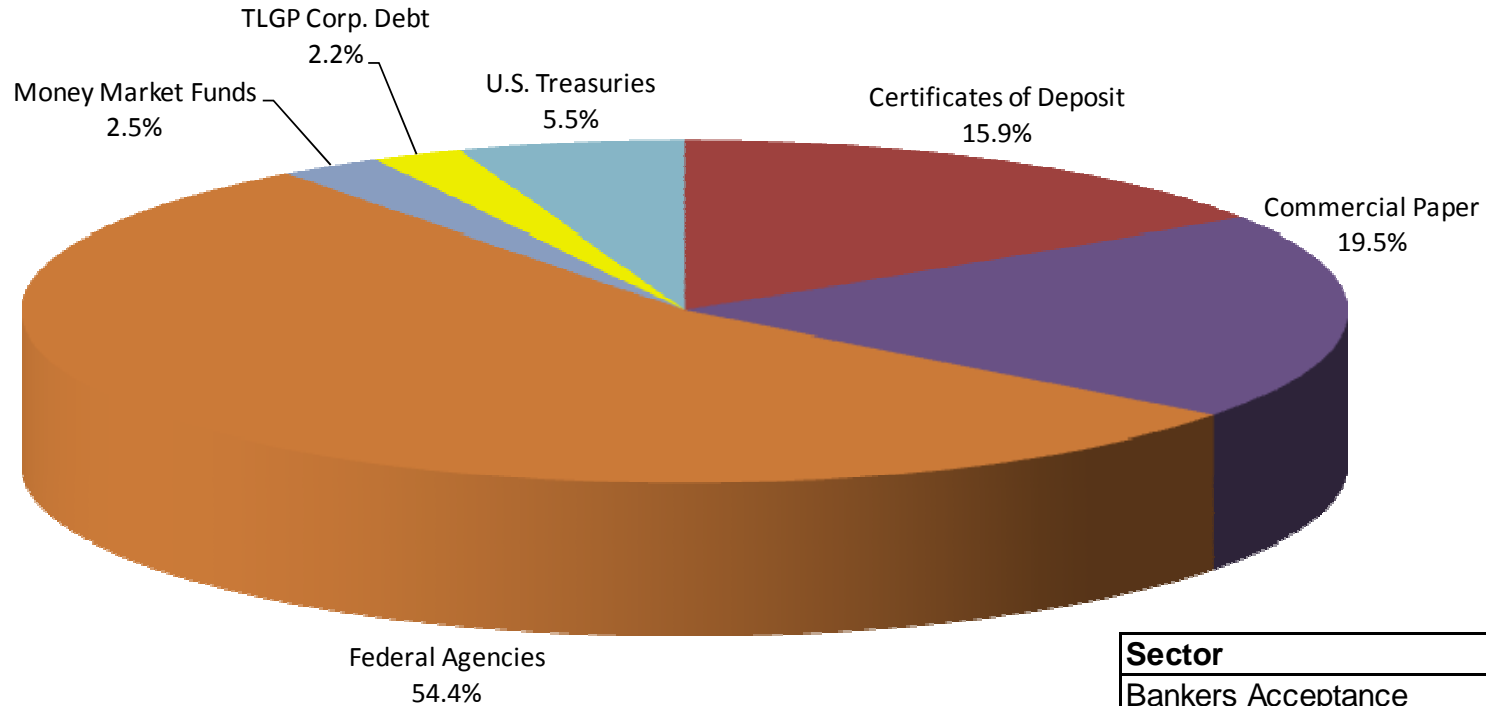

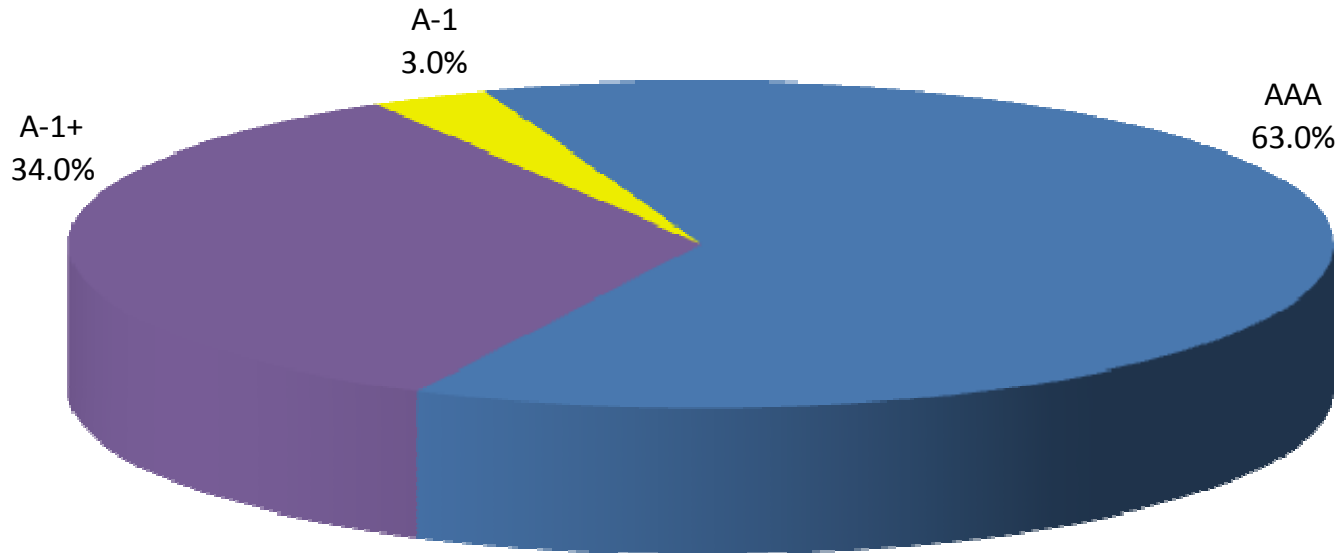

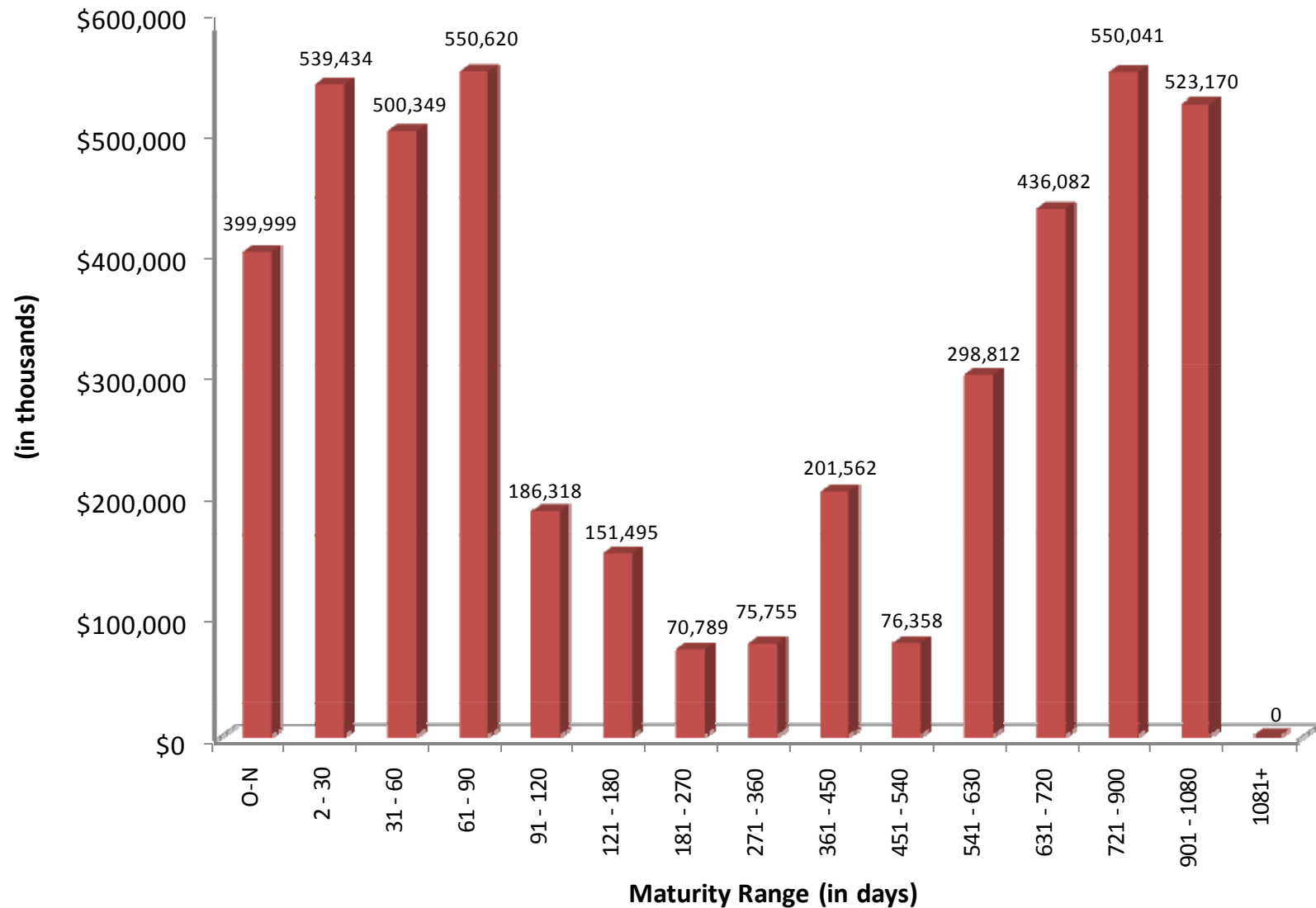
# San Bernardino County Pool Credit Quality Distribution (as of 3/31/11)
