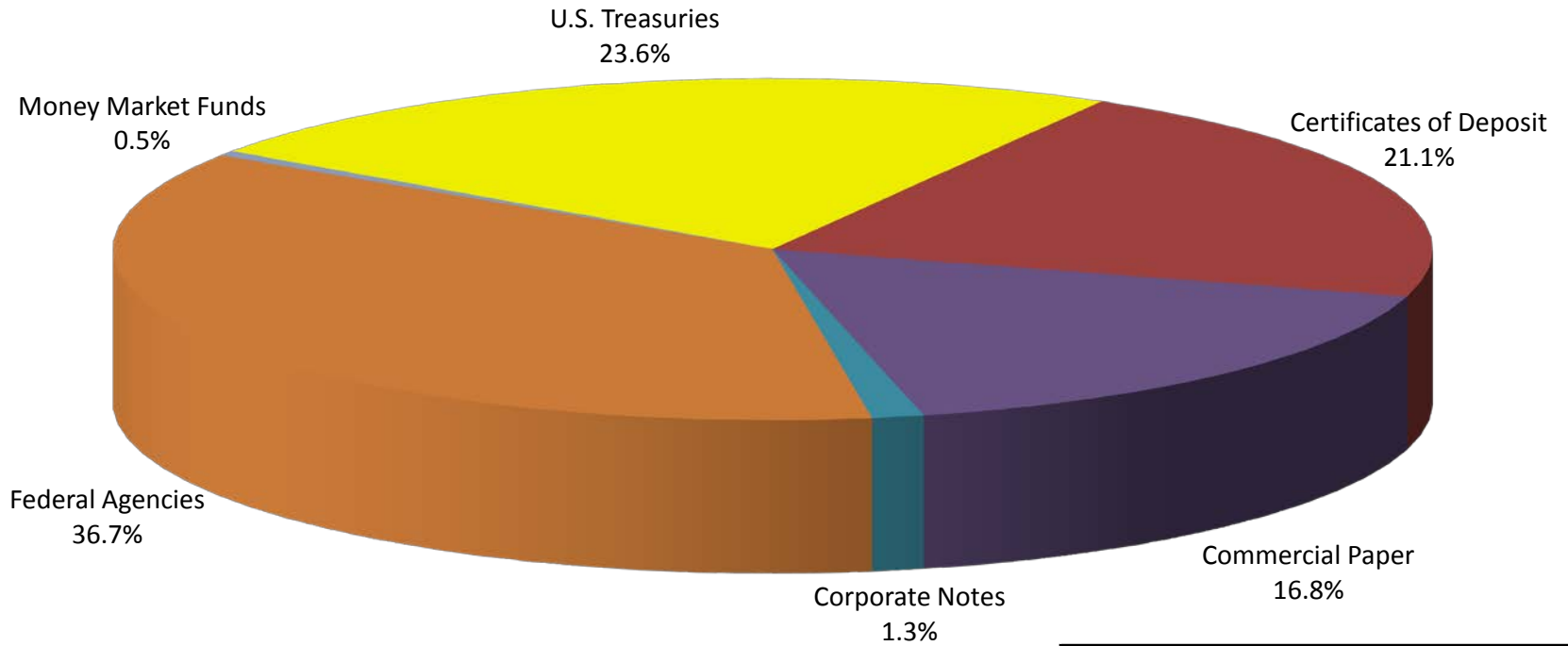

# San Bernardino County Pool Sector Distribution (as of 5/31/2014)

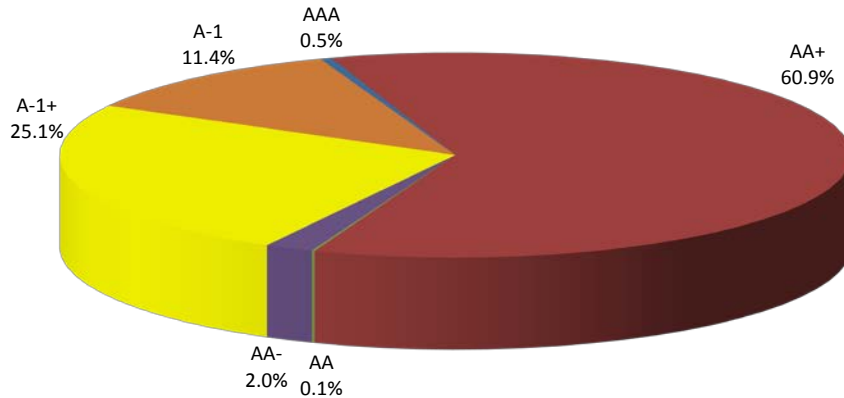

# San Bernardino County Pool Credit Quality Distribution (as of 5/31/2014)

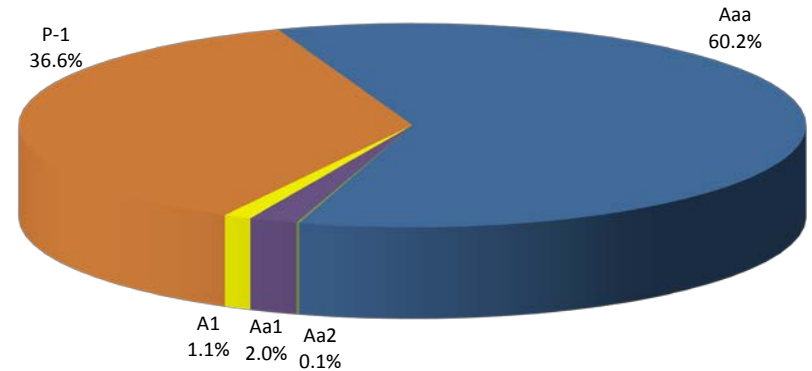

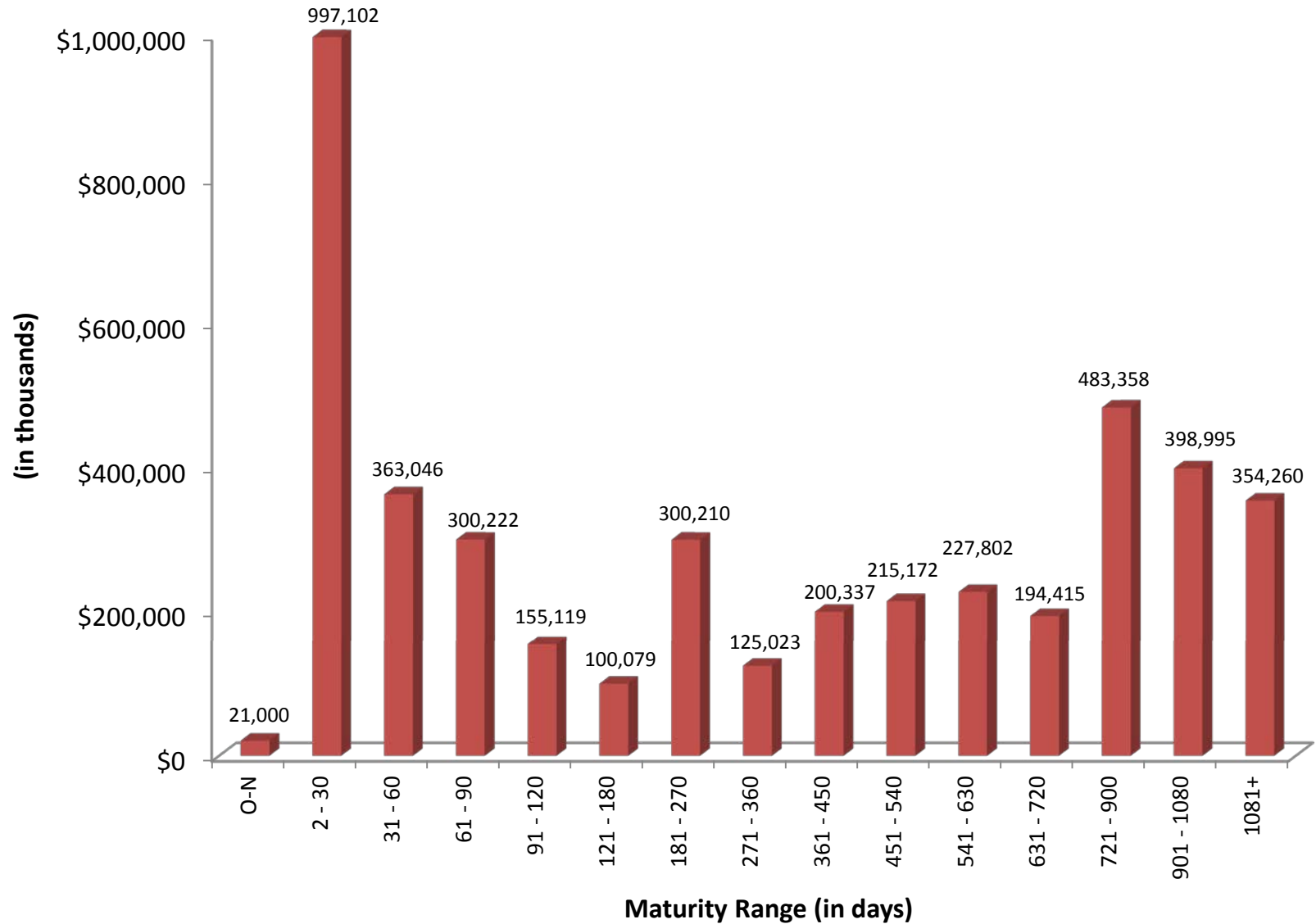
