## **Male pedestrian in hospital after being hit by car in Hesperia**

A 58-year-old male pedestrian is in the hospital after being struck by a vehicle Monday night in Hesperia, the San Bernardino County Sheriff's Department said.

The incident occurred near Main Street and Third Avenue. Deputies and **San Bernardino County Fire** Department personnel were alerted to scene at 6:20 p.m., a sheriff's news release said. The man, who is from Hesperia, was found down in the westbound lanes of Main Street.

The man was suffering from major injuries, the release said. He was taken to Arrowhead Regional Medical Center and is receiving treatment.

Deputies, based on witness statements and evidence on the scene, believe the pedestrian was crossing Main, west of Third, when he was struck by a Chevrolet sedan, the release said. He was not walking in the cross walk. The driver of the sedan cooperated with investigators and was not injured.

## **Hesperia man struck by vehicle on Main Street, airlifted to trauma center**

HESPERIA — A 58-year-old man was airlifted with major injuries after he was struck by a vehicle here Monday evening.

San Bernardino County Sheriff's Hesperia Station and **County Fire** Department personnel responded to a call of a vehicle vs. pedestrian collision near the intersection of Main Street and Third Avenue at approximately 6:20 p.m.

According to authorities, a man, identified as Wayne Porter, of Hesperia, was found down in the westbound lanes of Main Street suffering from major injuries as a result of the collision.

“Based on witness statements and evidence at the scene it was determined that Porter had been crossing Main Street, west of Third Avenue, outside of the marked crosswalk when he was struck by a 2011 Chevrolet sedan traveling west in the number two lane of Main Street,” sheriff's officials said in a statement.

The collision caused major injuries to Porter, as well as major damage to the Chevrolet, and Porter was airlifted to Arrowhead Regional Medical Center where he is receiving ongoing treatment for his injuries, authorities said.

The driver of the Chevrolet cooperated with investigators and was uninjured.

The Hesperia Sheriff's Station Traffic Division is conducting the investigation into the collision and anyone with information is urged to contact Deputy Jeremy Deberg or Sergeant Doug Hubbard at 760-947-1500

## **Pedestrian Suffers Major Injuries After Being Struck by Vehicle**

**HESPERIA** – A 58-year-old Hesperia man was badly injured after being struck by a vehicle on Monday evening officials said.

At around 6:20 p.m. deputies from the Hesperia Stations and personnel from the **San Bernardino County Fire** Department were dispatched to the vehicle versus pedestrian collision near Main Street and Third Avenue. When they arrived they found the male pedestrian, later identified as Wayne Porter, 58, of Hesperia lying on the westbound lanes of Main Street suffering from major injuries as a result of the collision.

Porter sustained major injuries and was airlifted to Arrowhead Regional Medical Center where he is receiving ongoing treatment for his injuries. The vehicle also sustained major damage. Witnesses reported and evidence collected the scene revealed that Porter was crossing Main Street, west of Third Avenue outside of the marked crosswalk when he was struck by the 2011 Chevy sedan which was traveling westbound in the #2 lane of Main Street.

The driver of the vehicle did not sustain any injuries as a result of the collision and remained at the scene and cooperated with the investigation. The Hesperia Station Traffic Division is conducting the investigation and anyone with information regarding the collision is asked to contact Deputy Jeremy Deberg or Sergeant Doug Hubbard from the Hesperia Sheriff's Station at (760) 947-1500.
